**Competitors that enter both CKC and CARO each day (4 runs) will get a \$15 credit toward any Red Barn or Simcoe Performance Dogs trial!!! All runs after the 4 runs each day will continue to get another \$3 credit per run. This can be combined between different dogs, the owner/handler must be the same person.**

## GENERAL INFORMATION

1. The **trial precincts** shall be the entire building of Companion dog Training.
2. Show Superintendent has full charge of the show which is governed by CKC rules.
3. The Red Barn Events Center and Simcoe Performance Dogs will use **due care and diligence** for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
4. **Obedience Rules & Regulations. Chapter 20.7 - It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience or Rally Trial held under these regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.**
5. **BITCHES IN SEASON** are not permitted to compete. When a bitch comes into season after entries close, a Veterinarian's certificate, certifying that the bitch was in season within ten days of the trial, must reach the Trial Secretary on or before the day of the trial, prior to the judging of the class, and the club will refund the entry fees.
6. **CKC Non-membership participation fee** – i) A non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. ii) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. iii) In order for titles to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. iv) All Premium Lists will carry a note stating that these fees apply only to dogs wholly owned by non-member residents of Canada and are not applicable to CKC members.
7. **Mix Breeds and Unrecognized Breeds** must have a Canine Companion Number (CCN) from the CKC to enter the trials. A dog eligible for a CCN may not be entered as a listed dog.
8. If, because of riot, civil disturbance, or other acts beyond the control of management, it is impossible to open or complete the trials, no refund of Entry Fees will be made.
9. The owner or handler of the dog must complete and sign the **Liability Agreement**. Incomplete entries will be returned. Entries will only be accepted if accompanied by correct fees. Courier entries will be accepted if no signature is required.
10. Move ups will be allowed if received 15 minutes prior to the beginning of the class being moved into.
11. Tendering of **NSF cheques** is considered as non-payment of fees and is punishable by disciplinary action. NSF cheques will be subject to a \$30.00 fee
12. **Foreign Exhibitors** please note that fees are due in Canadian dollars. Discounted cheques will not be accepted. Personal cheques payable in Canadian funds will be accepted. Please do not mark personal cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. Please purchase bank drafts or money orders payable in Canadian dollars.

## CKC Rally Obedience Classes:

(Although adapted from the CKC Rally Obedience Rules and Regulations, this list is a summary which is not meant to replace reading of the CKC Obedience Rules & Regulations)

**Novice A** - Dogs competing in this class may not have won a CKC Rally nor Obedience title. No handler who has exhibited a dog through its CKC CDX or instructed dog training classes is eligible for this class. The handler must own, co-own or be an immediate member of the dog owner's family. A person may enter more than one dog in this class. Once official notice of achieving this title is received by the CKC, a dog MUST move to either Novice B or Advanced A.

**Novice B** - for handlers or dogs who do meet requirements or Novice A. Dogs may compete in this class until they early a Rally Advanced leg.

**Intermediate**—Dogs/owners that have earned the Rally Novice title may choose but are not required to enter this optional class prior to Rally Advanced

**Advanced A & Excellent A** - Dogs/owners that were eligible to compete in Novice A continue in the A level classes until their achieve their Rally Excellent title.

**Advanced B & Excellent B** - Dogs/owners that competed in Novice B continue in B level classes. A dog may continue to compete in the Excellent B class indefinitely.

**Master**—Dogs/owners that have earned the Rally Excellent may choose to but are not required to enter the Master Rally class. A dog may continue to compete in the Master class indefinitely

**Exhibition Only** - an official class for dogs NOT entered in a regular class, however dogs in non-regular classes or dogs that are not exhibiting at the trials MUST be entered in this class

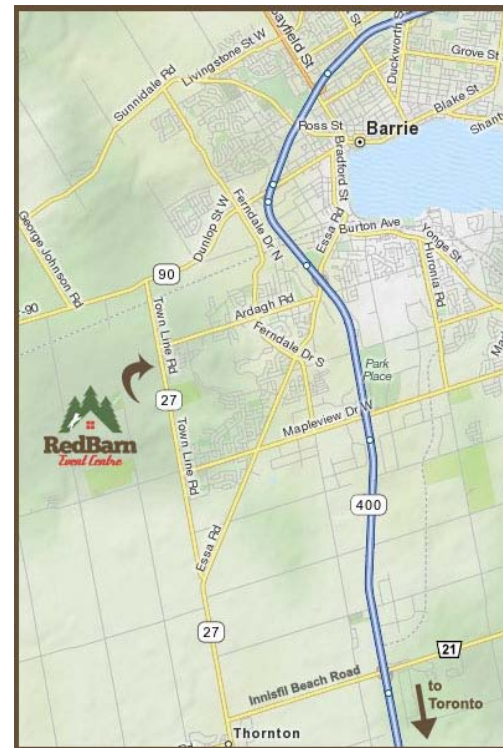

Alterations, substitutions or cancellations of any entry after the closing date is prohibited, except as noted in this premium list. The ONLY exception is bitches in season. Unfortunately we can not refund any entries, after closing, for injured dogs or any other reason. Anyone wishing to pull their entries after the closing date BUT prior to the start of the trial weekend will receive a credit in the amount of 50% of their entry fees towards a future PDC CKC trial held within twelve (12) months of this trial (excludes online entry service charge if applicable). Request MUST be made in writing to the trial secretary PRIOR to the start of the first trial.

## Directions to The Red Barn Event Centre:

From the 400: Take the Essa Road exit. Turn west on Essa (sign says Essa Road South). Turn right at Ardagh Road. Follow Ardagh to County Road 27. Go South on County Road 27.(aka Town Line Road) Property is on the west side of the road down a long driveway. There is a private residence at the front of the property.

From CR 27 South: Follow CR 27 northbound through Thorton. Continue north. After 5 minutes, look for signs on your right that show you have to turn LEFT to stay on CR 27. When you see that sign, turn left, continue on CR 27. When you come down the big hill look for our white flags on the west (left) side of the road. If you get to lights at Ardagh, you've gone too far.
