**NO POST DATED CHEQUES ACCEPTED.** ALL NSF cheques are subject to a charge of \$25.00. N.S.F. cheques are considered Non-Payment of entry fees and are punishable by disciplinary action and cancellation of awards. All fees must be paid before the shows/trials.

**Attention Foreign Exhibitors:** Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted, however, they are to be payable in Canadian Funds. If you send a cheque in US Funds it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not make cheques "Payable in Canadian Funds", they will not be cleared by the banks. To simplify the process, we urge you to purchase bank drafts or money orders payable in Canadian Funds. **NON MEMBER PARTICIPATION FEE**

An annual "Non-member" participation fee for Awards and Titles will be charged to a Canadian "non member" of the Canadian Kennel Club. This fee will match the fee charged for Event Registration Number. In order to protect the Awards and Titles earned, the "non-member" will have a choice to (a) either become a CKC member; or (b) pay the "non-member" participation fee. Failure to comply within 30 days of notification will cause All Awards and Titles to be cancelled.

Please Note: These fees only apply to dogs wholly owned by "Non-CKC" members and are not applicable to CKC members.

**BITCHES IN SEASON:** A Bitch in season may not compete in Obedience or Rally Trials. Entry fees will be refunded ONLY if the Trial Secretary BEFORE commencement of the trial receives a Veterinarian's Certificate. Refunds for any other reason will not be given.

**Show precincts shall be the StayNPlay Canine Centre event space. No unentered dogs will be permitted with in the trial precincts during trial hours as outlined by the Judging Schedule. Set up times for exhibitors will be listed in the judging schedule.**

**ENTRY IDs:** A conformation of entry/Exhibitor ID and Judging Schedule will be emailed to the email address provided on the entry form no less than 7 days before the first day of trials. None will be sent by regular post mail; exhibitors are responsible for legibly entering their email on the form, and checking spam/junk folders for delivery.

*Parade of Veterans*

Participating dogs must be 7 years of age or older on the day of the event.

**VETERANS CLASS (Obedience Only)**

The Veterans class shall be for any dog that has earned the title of CD or higher and is seven (7) years old or older on the day of the trial.

**TEAM CLASS (Rally Only)**

The Team class is open to any four dogs that have earned the title of RN or higher. It is not necessary that the same person own all dogs in the team or that they be of the same breed.. A 5<sup>th</sup> dog may be entered to serve as an alternate; but the same 4 dogs must complete all exercises and at the same level. Please indicate the level on the entry form for each dog, if jumps are required, height is calculated by smallest team member. Please provide the show secretary a list of team members.
