

## DIRECTIONS to reach WIMBERWAY FARMS:

From Toronto/ points South: take Hwy 400 north to Hwy 11, then north to Powassan, (approx 3 hours from 400/401 interchange).  
From points East: take Hwy #17 west to Corbeil Corners; south on # 94 to Hwy # 654, then EAST to Hwy # 11. South on # 11 to Powassan.  
From points West: take Hwy 17 east to North Bay, then south on Hwy # 11 to Powassan.

At Powassan, take the Clark St./Hwy 534 exit. At top of exit ramp, turn RIGHT onto Clark St., and in to town.

Clark St. ends at Main St. Turn right onto Main. Take first left: Memorial Park Dr.

We are 808 Memorial Park Dr., just under 4 km east of Main St.

Please use parking area with entry between the two stone cribs....between the west pond, and the fenced training area.

### Trophies

**Ribbons:** Flat Ribbons will be offered in each jump height in each class for all qualifying scores 1<sup>st</sup> - 4<sup>th</sup> placement. Titling Ribbons will be offered for new titles.

Show precincts shall consist of 10' in all directions of the ring area.  
Ring is 100' by 100' grass surface

Obstacle familiarization will be available for Novice classes immediately prior to the first Novice Standard class of EACH day. Dogs may only participate in the familiarization on the first day of the weekend that they are entered.

Obstacles shall meet the specifications in the CKC Agility Rules and Regulations effective January 1, 2010."

**MOVING UP:** Dogs may move up on the day of the trial one hour prior to the commencement of each trial.

### Non Member Participation Fee - Effective 1 January 2012

- A non-member participation fee will be charged to a resident of Canada who is not a-member of the CKC. The fee will be \$58.50 plus applicable taxes.
- The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- The fee applies only to dogs wholly owned by non-member residents

### Attention Foreign Exhibitors

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. ## Agility Rules & Regulations

**Eligibility:** To be eligible to compete in an agility trial, the dog must be registered with the CKC, be eligible for registration with the CKC, have an ERN, or have a CKC Miscellaneous Certificate number. A dog may be spayed, neutered or debarked.

**Bitches in Season** are not permitted to compete. The judge of an agility trial must remove from competition any bitch in season, or any bitch which appears so attractive to males as to be a disturbing element. When a bitch comes into season after entry of the bitch has been submitted to the trial Secretary and a Veterinarian's certificate that the bitch was in season within the ten day period preceding the trial, the Trial giving club will refund entry, service charges and listing fees.

An ERN must be obtained within thirty (30) days of obtaining points, awards or scores to avoid cancellation. If factors beyond your control prohibit this or present a problem, please send a written request for a 30 day extension.

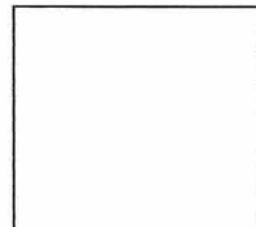
