**Note**: A Listing Fee as established by The Canadian Kennel Club must accompany the entry of a dog for which a Canadian Kennel Club individual registration number, Event Registration Number (ERN), Performance Event Number (PEN) or Miscellaneous Certification Number (MCN) is not shown on the entry form.

### **ENTRIES**

**NOTE: There are no FDX or FDXCH classes offered at these tests!** Dogs must be 6 months or older to be entered. Entries are limited to the number of dogs able to run during daylight hours and may be limited for brace categories. No entry will be accepted from any person who is not in good standing with the CKC.

Entries close midnight on Tuesday, September10, 2019. If your dog has twice qualified with any of our Judges, notify the Test Secretary <u>before</u> the drawing time. Entrants are responsible for confirming receipt of their entries.

## LATE ENTRIES

<u>FDJ and FD classes only</u>. Use late Entry Form or Online Form. If accepted, they constitute a legal commitment to pay and cannot be withdrawn or refunded. Online form for late entries to be disabled at 6:00 PM Saturday, September 15, 2019 or sooner if test is filled. Paper entries must reach the Test Secretary no later than onehalf hour before the test start time.

## **CANCELLATIONS & REFUNDS**

Cancellations with full refund must be in writing to <u>field@vsovizsla.org</u> and received before official closing. No refunds after closing or for bitches that come into season after closing.

### NON-PAYMENT OR DISHONOURED PAYMENT

Payment must be made in full and accompany the entry form. The VSO reserves the right to refuse entries from persons who have failed to pay entry fees in full at prior tests. Tendering of a dishonored cheque or declined credit card shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards. Postdated cheques are not acceptable tender.

### **MORE INFORMATION**

**Start times:** Saturday: 7:30 AM; Sunday: 8:00 AM **Running Order:** FDA, FD and FDJ. FD dogs may be slotted in between braced classes (FDA) to allow judges and handlers handling multiple dogs to rest.

**Course and Game:** FDJ, FD, and FDA will be a single course with bird field. FDA dogs will be run in braces or individually where applicable with a bye dog for backing.

Birds: Chukars will be used in all categories.

**Gunning**: Official gunners only. All handlers must carry a starter pistol.

**Safety Gear**: All entrants, judges, gunners, volunteers and spectators who enter or are physically present on the test course, must wear blaze orange clothing <u>and</u> blaze orange head gear in any test where shotguns are used. (Clause 11.3 of CKC *Field Dog Test Rules and Regulations for Pointing Dogs*.)

**Indemnity & Waiver**: All participants are required to sign the attached VSO waiver on page 6 either in advance of or at the test. Any spectator wishing to accompany and view a running dog in the test course must also sign a waiver and wear safety gear as outlined above.

**Immunization**: All dogs must have current immunization status before being entered.

**Other**: If a dog is not present at its starting point within 5 minutes after it is called for by the judges, it may be disqualified. No training or running of dogs on the grounds before and during the tests. We highly recommend tick prevention be used on dogs, handlers, spectators and volunteers.

**Bitches in season:** are permitted ONLY in FDJ Test# 2 and Test #3 and will be run at the end of the day.

**Meals and Refreshments**: Morning coffee will be available both days as well as lunch at a nominal fee for entrants. Judges and volunteers will be fed first.

#### **DRAWING & RUNNING ORDER**

**Draw**: Running order draw will take place at the home of Test Secretary in Moffat, ON 905-691-8706 on Wednesday September 11<sup>th</sup> at Noon. Specific times cannot be guaranteed.

**Running Order**: A running order will be e-mailed to all entrants who provide an e-mail address.

#### **MOVE-UPS**

**Move-ups** must be done in writing to the Test Secretary at least one hour prior to the start of the test. Move-up to a braced class is only permitted if another brace mate or bye dog is available.

#### GOOD SPORTSMANSHIP

All who attend our tests, in any capacity, are expected to conduct themselves in a manner which reflects credit to themselves, their dogs and the sport of purebred dogs, regardless of circumstance and location. Under Section 7 of the CKC Field Dog Test Rules and Regulations for Pointing Dogs, the Test Committee as well as Judges have the authority to expel any individual who, in their assessment, displays unsportsmanlike behaviour.

#### PRIZES AND AWARDS

- Standard CKC Blue Ribbons to dogs with qualifying scores.
- New Title Rosette to each dog completing the requirements for a title (these will <u>not</u> be mailed so please notify the Test Secretary at the time of the announcement of scores).
- Rosettes to each Jr. Handler (18 yr. and under) whose dog has received a qualifying score. These will not be mailed. Please identify if a Jr. Handler is running a dog on the entry form.
