## Directions to the Trial Site Obedience:

### From the US

Hwy. 61 to Harbourview Expressway, turn right.

Keep in left hand lane. Third set of traffic lights: " **Fort William Rd**".I.D. (Sears Store on right) **YOU TURN LEFT (Fort William Road)**

### From Kakabeka

follow highway to Fort William Rd.(Sears Store on right).

**YOU TURN LEFT (Fort William Road)**

~ get in **right hand lane**. I.D. Greyhound Depot / prepare to turn one block down ~ on right hand side, you will see Leon's Store, and a sign on the corner that reads: **CENTRAL AUTO PARTS...Turn Right**. Street: **Burbidge**.

Next & only street, **FORTUNE STREET. TURN LEFT.**

Continue on to the end, you will see a sign on fence, CDC, continue through gates, we are the last door on the right hand side.
