

This is an indoor show. The building will be open on Thursday –

September 25 – from 3pm to 10pm. Friday/Saturday – September 26/27 from 6am to 10pm. Sunday – September 28 – from 6am to one hour after Best in Show judging.

NO PERSONS OR DOGS SHALL BE ALLOWED IN ANY PART OF THE BUILDINGS NOT DESIGNATED FOR SHOW USE.

#### **RULES GOVERNING THESE SHOWS**

- 1. THE CLUB RESERVES THE RIGHT TO REMOVE ANY PERSON FROM THE SHOW. THE SHOW SUPERINTENDENT SHALL HAVE FULL CONTROL OF THESE SHOWS AND TRIALS, WHICH WILL BE GOVERNED BY CKC RULES.
- 2. ANY DOG EXCUSED BY THE SHOW SUPERINTENDENT OR VETERINARIAN FOR ANY REASON SHALL NOT, COMPETE IN ANY CLASS FOR ANY AWARDS FOR THE BALANCE OF THE SHOW.
- 3. THE SHOW COMMITTEE WILL USE DUE CARE AND DILIGENCE FOR THE WELFARE OF DOGS AND EXHIBITORS, BUT WILL NOT BE RESPONSIBLE FOR, OR ASSUME ANY LIABILITY IN THE EVENT OF ACCIDENT OR MISFORTUNE TO EITHER DOGS, EXHIBITORS, SPECTATORS OR VENDORS.
- 4. DOGS MUST BE ON THE GROUNDS 1 HOUR PRIOR TO THE JUDGING OF THEIR BREED.
- 5. THE OWNER OF A DOG ENTERED IN THESE SHOWS IS ENTIRELY RESPONSIBLE FOR ANY ERROR IN ENTERING HIS/HER DOG REGARDLESS OF HOW OR BY WHOM THE ENTRY WAS MADE.
- 6. EXHIBITORS AND HANDLERS WILL BE RESPONSIBLE FOR THEIR DOGS AND EQUIPMENT LEFT AT THE SHOW GROUNDS.
- 7. DOGS ARE TO BE EXERCISED IN DESIGNATED AREAS ONLY, NOT IN VICINITY OF SHOW RINGS
- 8. ALL REACREATIONAL UNITS WILL HAVE BUCKETS UNDERNEATH FOR THEIR SINK DRAINS. ANYONE FOUND DISCHARGING WATER ON THE GROUNDS WILL BE REMOVED BY ORDER OF THE HEALTH DEPARTMENT, AND MAY BE SUBJECT TO A FINE.
- IF, BECAUSE OF CIVIL DISTURBANCE OR OTHER ACTS BEYOND THE CONTROL OF THE CLUB, IT IS IMPOSSIBLE TO OPEN OR COMPLETE THE SHOW, THERE IS NO REFUND OF ENTRY.
- 10. DOGS MUST BE ON LEASH AT ALL TIMES ON THE SHOW GROUNDS OR WITHIN THE SHOW BUILDING.

# ALL EXHIBITORS, HANDLERS AND PATRONS ARE EXPECTED TO KNOW AND ABIDE BY THE CKC DOG SHOW RULES

SECTION #1. A dog awarded WINNERS at a Championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5), and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder. SECTION #2. The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows;

To determine the number of points earned by a dog awarded Winners, total all dogs in competition which were defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best Opposite Sex and then consult the schedule set forth above. The point system provides for additional points if a class dog awarded Best of Breed also places in the group as listed below:

A class dog awarded Best in Show at an all-breed Championship show will be credited with 5 points inclusive of any points earned at the breed or group level. In counting the number of eligible dogs in competition, a dog that is disqualified or that is dismissed, excused or ordered from the ring by the judge, shall **NOT** be included in the calculation for championship points (effective January 1, 2012) (Absentees are not to be included). In order for a dog to be recognized as a Canadian Champion it must: (1) earn at least ten championship points under at least three different judges; and (2) be individually registered in the records of the CKC or have a CKC Event Registration Number (ERN)

# Dr. Andi Hudono SpOG, MRCOG (HARMONIC)

I graduated in 1978, from the University of Indonesia medical school and obtained my degree and training in Obstetrics and Gynaecology in England. I am a member of The Royal College of Obstetrician and Gynaecologist, England and a practicing consultant in Jakarta (Indonesia), specializing in infertility.

From a young age, I have always have dogs and from 1972, I started breeding and showing Chihuahua, Pekingese, Miniature Pinscher. My first import from England was a Chihuahua.

My first Miniature Pinscher import was a red male in 1983 from Japan, named Atom of Starprize. This dog became an Indonesian Champion and the no.1 Miniature Pinscher in Indonesia. I have also bred Miniature Pinscher.

My interest also extends to Pomeranians, imported from England. They become Indonesian Champions and Reserve Best in Shows. I bred and focused my Pomeranians from Hadleigh, Tookeyes, Toybox, Pomirosa and Bilijees Lineage.

From England, I imported Mini Smooth Dachshunds and Boxers.

Mini Smooth Dachshund was Ch.Tanska Macvity, I have bred and showed Mini Smooth Dachshund successfully. The Boxers came from the famous Marbelton Kennel. I have campaigned Ch. Marbelton French Connection, Ch.Maromad Chase the Lady of Marbelton, and bred Ch. Harmonic Cleo Laine, several CC winners.

The first Dobermann I owned was in 1978. My first import in 1980 was a brown male, Moonbeam Showboat from the USA. This dog became the no.1 Indonesian Dobermann, and then went on to become Indonesian, American, and Canadian Champion. My other import from USA was Ch.Zeitlin Bedazzled von Kerry.

Later I imported Dobermann from the famous Franckenhorst breeder and dogs with Nordenstamm Bloodlines from Europe.

Harmonic Dobermanns are the result of these Americans, Franckenhorst and Nordenstamm bloodline combinations. My latest import was a black male Ch.Bilbao Dente Del Gigante from Europe and in 2005 became The Top Male Dobermann.

Harmonic have been chosen as Best Breeder at the National Dobermann Club of Indonesia Specialty Show for 4 consecutive years (2004 – 2007) and 2011 I have exported Dobermanns to Singapore, India, England and Europe.

I am a founding member and the breed counsellor of The Dobermann Club of Indonesia. I had served for several years as a breed counselor, committee and now **The Vice President / Show Chairman of The Indonesia Kennel Club** (PERKIN).

During my stay in England, I visited and gained first-hand experience and knowledge from famous breeders there, such as Ocobo (English bulldog),

Yeosinga, Apoco Deodar (Chihuahua), Ashgate (West Highland white terrier), Fantasia/Upend (Rottweiler) and several others.

To date, I have breed and owned over 50 Indonesian, Indian, Japanese, Singaporean and American Champions.

My first appointment to judge Dobermann from The Indonesian Kennel Club was in 1993. In 2006 I have been approved to judge by The Dobermann Club in England, and in 2009 The Kennel Club in UK approved me to give CC merit in UK.

At present I am licensed to judge and award challenge certificate on All Breeds including FCI Shows, and have judged Specialty, Multi Breeds, and All Breeds Shows.

I have judged in Europe at the prestigious Euro Dog Show in Kortrijk Belgium in 1998 & 2003. I have also judged in England 2008, Thailand 2009, Australia (Melbourne and Adelaide) January 2010, and Malaysia July 2010, Singapore, United Kingdom and Denmark August 2010, Philippine and Japan Oct 2010, Korea, Australia / Sydney "NSW Spring Fair Dog Show 2010" Nov 2010 (Best In Show), Melbourne and New Zealand January 2011, Ireland April 2011, Thailand June 2011, Sweden August 2011 (Best in Show), Taiwan October 2011, Japan November 2011, India January 2012, Denmark May 2012, Thailand June 2012, Australia Sep 2012, India January 2013, Japan February 2013, Denmark May 2013, New Zealand May 2013, South Africa July 2013 and various cities in Indonesia. I will also be judging in India September 2013, China September 2013, Philippine December 2013, England, Portugal and Spain May 2014, Brisbane and Adelaide June 2014.

He was also the past president of the Philippine Dobermann Federation, a Charter Member of the Philippine Rottweiler Club, and was also a member of both the Miniature Pinscher Club and Dobermann Pinscher Club of America.

# EXTRACTS FROM CKC CONFORMATION SHOW RULES

#### CHAPTER 4.1.3 - JUDGES

A judge officiating at a show held under these rules shall not be subjected to any indignities of any kind during the progress of the show, and it shall be the duty and obligation of the club holding the show to see this rule is effectively enforced.

### 8 - ENTRIES and ENTRY FEES

Section 3.1 Every dog entered in Championship Shows held under these rules must be registered, have an Event Registration Number, eligible for registration with the CKC or have a CKC Miscellaneous Class Certification number issued by the CKC Chief Registrar. If a dog is not registered individually in the CKC it may be entered at a show, held under these rules, as a "listed" dog, provided

- (a) it is not a Miscellaneous breed
- (b) if born in Canada, is eligible for individual registration

(c) if foreign born and owned, an Event Registration Number or CKC registration number is obtained from the CKC within 30 days of the first show entered. A listing fee of \$8.82 must accompany the entry of a "listed" dog at a show held under these rules.

## Section 2.3:

#### INCOMPLETE ENTRIES

Entry forms which are incomplete or those that contain incorrect information after the closing date of entries will be void and under no circumstances can changes be made. Any dog taking a win resulting from such an entry will result in the wins being canceled, and persons making such changes will be subject to disciplinary action.

## Section 8.2:

#### DISHONORED CHEQUES

Tendering of a dishonored cheque or credit card in payment of entry fees shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards. Clubs may refuse to accept entries from any exhibitors who have been known to tender dishonored cheques in payment of entry fees unless such entries are accompanied by a money order or certified cheque.

CHAPTER 14 - DISQUALIFICATION

#### Section 1.4

A dog once disqualified for any reason at a Championship show held under these rules cannot again be shown or entered at a show held under these rules unless and until said dog has been reinstated by the CKC. All awards earned by a dog shown in violation of this section will be canceled by the CKC and the owner of said dog is subject to disciplinary action. Note: for any further information on reinstatement refer to Chapter 16, Section 3 of the CKC Dog Show Rules

#### CHAPTER 9 - EXHIBITORS and THEIR DOGS

A show-giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent.

DOGS AND EQUIPMENT MAY BE LEFT IN THE BUILDING AT OWNERS/AGENTS OWN RISK. (Please read "Agreement" on the backside of the entry form).

# **CONFORMATION CLASSES**

The following Regular CKC Classes (divided by sex) will be offered <u>JUNIOR PUPPY CLASS</u> - This class shall be for any dog 6 months of age and under 9 months of age on the day of the show

<u>SENIOR PUPPY CLASS</u> - This class shall be for any dog **9** months of age and under 12 months of age on the day of the show

<u>12 to 18 MONTH CLASS</u> – This class shall be for any dog **12 months of** age and under 18 months of age on the day of the show

<u>CANADIAN BRED CLASS</u> - This class shall be for any dog born in Canada. (Champions of any country excluded)

**BRED BY EXHIBITOR CLASS** - This class shall be for any dog owned and handled in the ring owner/breeder. The handler <u>MUST</u> be the owner/co-owner <u>AND</u> breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards <u>OPEN CLASS</u> - This class shall be for all dogs

<u>SPECIALS ONLY CLASS</u> - This class shall be for any dog which has a recorded CKC Registration or Event Registration Number and has attained the required points for Championship status. <u>Note</u>: A Listed dog <u>MAY</u> be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class <u>MUST</u> be received by the Show Secretary ONE HOUR PRIOR TO THE OPENING OF THE SHOW ON THE DAY CONCERNED. Listing Fees <u>WILL NOT</u> be refunded

**EXHIBITION ONLY** - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class <u>MAY NOT COMPETE</u> in any Regular class but may enter and compete in Non-Regular classes and/or Parades ONLY

#### NON-REGULAR CLASSES

<u>BABY PUPPY CLASS</u> - This class shall be for any dog 3 months of age and under 6 months of age on the day of the show. (note: winners of these classes DO NOT COMPETE FOR POINTS). <u>The class will be judged after Best Puppy in Breed, after Best Puppy in Group, PRIOR to Best in Show</u>

<u>VETERANS CLASS</u> – Dogs must be 7 years of age and over on the day of the show. Dogs entered in this class may be spayed or neutered. Awards for this class are: Best Male Veteran, Best Female Veteran, Best Veteran in Breed, Best Veteran in Group, Best Veteran in Show (*This class will be held* on completion of Best Puppy in Breed, Best Puppy in Group and PRIOR to Best in Show)

<u>SEXUALLY ALTERED CLASS</u> - Eligibility for the Altered classes shall be limited to dogs over six months of age, which have been sexually altered by veterinary procedure. Points MAY NOT be carried from the regular competition judging to the Altered class judging. This class WILL be judged upon the completion of Veteran in Breed, Veteran in Group and Veteran in Show judging.

# **REGULAR OBEDIENCE CLASSES**

NO DOG MAY BE ENTERED IN BOTH NOVICE "A" & NOVICE "B" AT SAME TRIAL NO DOG MAY BE ENTERED IN BOTH OPEN "A" & OPEN "B" AT SAME TRIAL

NOVICE "A" - This class is open to all dogs, providing the dog has not earned the title of "CD" in ANY COUNTRY. The dog does not have to be CKC or ERN Reg'd to compete in this class. One dog ONLY may be entered in this class by any one exhibitor. The exhibitor MUST BE THE OWNER or A MEMBER OF HIS/HER IMMEDIATE FAMILY and MUST SHOW THE DOG IN ALL **EXERCISES.** No licensed handler, trainer or any person who has previously exhibited a dog through its "UD" title in Canada or Elsewhere shall be allowed to compete in this class, but MUST COMPETE IN THE NOVICE "B" CLASS **NOVICE "B"** - This class is open to all dogs that have not earned the title of "CD" in Canada. Dogs in this class may be shown by the owner or any other person. The dog does not have to be CKC or ERN Reg'd to compete this class OPEN "A" - This class is open to all dogs which have earned the title of "CD" IN CANADA, but have not earned the title of "CDX" in any country. One dog ONLY may be entered in this class by any one exhibitor. The exhibitor MUST BE THE OWNER or A MEMBER OF HIS/HER IMMEDIATE FAMILY and MUST SHOW THE DOG IN ALL EXERCISES. No licensed handler, trainer or any person who has previously exhibited a dog through its "UD" title in Canada or Elsewhere shall be allowed to compete, but MUST COMPETE IN THE OPEN "B" CLASS. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class OPEN "B" - This class is open to all dogs that have earned the title of "CD" in CANADA, and may be shown by the owner or any other person. This dog MAY ALSO COMPETE IN THE UTILITY CLASS. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class

<u>UTILITY CLASS 'A'</u> - This class is open to any dog of any recognized or listed breed which has earned the title of "CDX" but has not earned the title of U.D. Any person who has trained or exhibited a dog that has earned a M.O.T.Ch title may not handle dogs in this class.This dog must be shown by the owner or a member of their immediate families. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class. Owners may enter More than one dog in this class. The same person must handle the dog in all exercises. When a dog is wrongfully entered in this class, any score will be cancelled.

**<u>UTILITY CLASS 'B'</u>** - This class is open to any dog of any recognized or listed breed which has earned the title of "CDX" or U.D. Dogs in this class may be handled by the owner or any other person. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. No dog may be entered in both the Utility A and Utility B classes at any one trial. Prior to the start of judging, the judge will decide the order of exercises to be performed. This order will not be disclosed to exhibitors until it is posted at ringside, approx. 30 mins. Prior to the start of the class.

# TRANSITION OBEDIENCE CLASSES

<u>PRE-NOVICE</u> – This class shall be for all purebred dogs and those breeds as designated on the list of miscellaneous breeds and of either sex, which have not earned the title of P.C.D. (Pre-Companion Dog) in Canada. Dogs being entered in this class may be handled or exhibited by the owner or any other person. A person may enter more than one dog in this class and must have an additional handler for each dog when they are judged together on the Group exercise. A dog may be entered in the Pre-Novice that has not earned the title of C.D. in Canada or a comparable title in any other country. The Pre-Novice class is an elective class and earning a title is not a requirement to advance to the Novice Classes. The P.C.D. is an elective class which is offered for those people who feel the dog requires ring experience and acclimation to the trial situation or would like to earn additional titles.

**NOVICE "C"** - This class is open to any dog of either sex that has gained the title Companion Dog, Companion Dog Excellent, Utility Dog or any other advanced Obedience title in Canada prior to the closing date of the trial in which it is to be entered. Exhibitors may enter more than one dog in this class but must have a separate handler for each dog in the Long Sit and the Long Down Exercises when they are judged in the same group. The Novice 'C' exercises will be performed and judged as described in the official Novice Class except that exhibitors may compete in the Novice 'C' Class indefinitely. Scores earned by dogs entered in the Novice 'C' are elective classes which are offered for those people who feel the dog requires ring experience and acclimation to the trial situation or would like to earn additional titles. Dogs may be entered in the Novice – Intermediate (C.D.I.) and/or Novice 'C' class in addition to any of the Official Classes.

**NOVICE INTERMEDIATE CLASS** - This class shall be for all purebred dogs and those breeds as designated on the list of miscellaneous breeds and of either sex, which have earned the title of (C.D.) Companion Dog, Companion Dog Excellent, Utility Dog or any other advanced Obedience title in Canada. A dog eligible for entry in the Open A or B Class at any obedience trial held under these rules is also eligible for entry in the Novice 'C' and Novice Intermediate Class at the same trial. The Novice Intermediate class (C.D.I.) is an elective class and earning a title is not a requirement to advance to a Companion Dog Excellent title. Scores earned by dogs competing in this class are not eligible for High In Trial. Dogs are eligible to compete in this class indefinitely. Dogs in this class may be handled or exhibited by the owner or any other person. A person may enter more than one dog in this class.

<u>PLEASE NOTE</u>: The word 'trainer' means any person who conducts or has conducted a dog obedience training class or who regularly assists with the training of dogs in said class or who regularly trains dogs belonging to any person outside his/her immediate family

#### RALLY OBEDIENCE CLASSIFICATIONS NO DOG MAY BE ENTERED IN BOTH ADVANCED "A" & ADVANCED "B"

NO DOG MAY BE ENTERED IN BOTH EXCELLANT "A" & EXCELLANT "B"

**Rally Novice A Class:** Dogs competing in this class may not have won a CKC Rally Novice (R. N.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC CDX (Companion Dog Excellent) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

**<u>Rally Novice B Class</u>**: Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged on leash, and all dogs must enter and leave the ring on leash.

**<u>Rally Advanced A Class</u>:** This class shall be for dogs that have won the Rally Novice (R. N.) title but have not won the Rally Advanced (R. A.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC CDX (Companion Dog Excellent) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

**Rally Advanced B Class:** This class will be for dogs that have won the Rally Novice (R.N.) title. A dog completing the Rally Advanced (R.A.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash. All dogs must enter and leave the ring on leash.

**Rally Excellent A Class:** This class shall be for dogs that have won the Rally Advanced (R. A.) title, but have not won the Rally Excellent (R. E.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC CDX (Companion Dog Excellent) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

**<u>Rally Excellent B Class</u>**: This class will be for dogs that have won the Rally Advanced (R.A.) title. A dog completing the Rally Excellent (R.E.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash except the Honour Exercise. All dogs must enter and leave the ring on leash.
