## GREATER VICTORIA DOG OBEDIENCE TRAINING CLUB URBAN TRACKING TEST GENERAL INFORMATION

DATE: Sunday August 28<sup>th</sup> 2011  
ENTRY FEES: UTD \$75.00  
ACCEPTANCE DATE: 9 a.m. Tuesday July 19<sup>th</sup> 2011  
ENTRIES CLOSE: 5 p.m. Tuesday August 16<sup>th</sup> 2011

A listing fee of \$9.30 (\$8.30 + H.S.T.) as established by The Canadian Kennel Club must accompany the entry of a dog if a Canadian Kennel Club individual registration number or Event Registration Number (ERN) is not shown on the entry form.

Note: A Canadian TD title is a prerequisite for the UTD test.

All cheques/money orders are payable to **Greater Victoria Dog Obedience Training Club**. Please **DO NOT abbreviate to GVDOTC** – our bank will no longer accept this. All entries must be accompanied by appropriate fee.

U.S. Exhibitors - To pay in Canadian funds, use Postal Money Orders or the equivalent made out in Canadian dollars. Personal cheques will be accepted only if payable in U.S. funds for the full amount of the entry. Personally discounted cheques will not be honoured. Please do not mark personal cheques "Payable in Canadian funds" or "At par" as such items are not readily cleared through the banks. THANK YOU.

Bitches in season will be allowed to compete and will run last. Pinch or prong collars are not allowed on the Test grounds.

Rendezvous - Scheduled for 7:00 a.m. Sunday, August 28<sup>th</sup> 2011 at the Georgia Café in the Sidney Pier Hotel located at the bottom of Beacon Ave (street address 9805 Seaport Place) Sidney, B.C., where entrants will immediately draw lots for the order of the tracks. A no host lunch will follow. Confirmation of entry and directions to rendezvous point will be forwarded to each competitor upon receipt of entry.

Alternates - As of 1991, the C.K.C. has ruled that all Tracking Tests, having a limited entry, must accept alternates to their entry list. Entrants will be informed of their position on the alternate list immediately following the closing date of entries and will be informed of a cancellation up to 1 hour prior to the Test.

Refunds - Entry fees for dogs NOT entered in the Test will be refunded within 10 days of the tracking test. Refunds will not be given to those who have tracks and withdraw after the closing date.

As per C.K.C. rules (6.1.19), we are accepting entries through CANADA POST OR PRIVATE COURIER with ONE entry per envelope. ABSOLUTELY NO EXCEPTIONS. Please make sure NO SIGNATURE IS REQUESTED on entries sent via Express Post, Priority mail, or private courier.

Successful dogs - All exhibitors receiving a "pass" will be awarded a ribbon and a keepsake trophy.

ENTRIES CLOSE 5 p.m. Tuesday August 16<sup>th</sup> 2011, OR WHEN LIMIT IS REACHED.

**Discipline Regulation: It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. ### Non-member participation fee – Effective January 1, 2011

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.
