**ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Show Committee. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made.

All dogs must be exercised in the area provided for that purpose. All dogs must be on leash at all times except when in the ring.

T. D. S. reserves the right to refuse any entry, subject to C.K.C. Dog Show Rules.

Cancellation of an entry may be done prior to the closing date by notification in writing to the Trial Secretary. Please note that this trial could close before the published closing date if it becomes full based on times and the limited entry.

#### PLEASE NOTE THE FOLLOWING RULES:

1. A judge officiating at an obedience trial held under C.K.C. Obedience Regulations and Standards shall not be subjected to indignities of any kind during the progress of the obedience trial, and it shall be the duty and obligation of the club holding the trial to see that the C.K.C. is informed of any infringement of the Regulation, and the Board of Directors shall have the power to take such action as it deems fit on receipt of a report indicating that this Regulation has been violated.
2. Dogs must be kept under control at all times. Only dogs entered in these trials will be permitted in the building. T. D. S. will use due care for the welfare of all dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident, however caused, to either dog or exhibitor. No dog should be touched without permission of the owner or agent.
3. Only those dogs registered individually, or eligible for registration with the Canadian Kennel Club may enter.
4. No entries, changes or cancellations will be accepted after our published closing date. Entry forms must be complete in every respect. Exhibitors will abide by any errors made in entering their dog regardless of how, or by whom the error was made.
5. Bitches in season are not allowed to compete.
6. Refunds less C.K.C. fees will be given for bitches in season. Notification must be made to the Trial Secretary prior to the day of the trial accompanied by a Vet's Certificate.
