**Entry Fees:** TD: \$90 TDX: \$120 TCN Fee: \$11.30

**CKC 4.1.k:** A Temporary Competition fee as established by The Canadian Kennel club must accompany the entry of a dog for which a Canadian Kennel club individual registration number or Event Registration Number (ERN) is not shown on the entry form.

**US Exhibitors:** Payment **MUST** be made out for the full entry amount in **Canadian Funds**. USD personal cheques marked “Payable in Canadian Funds” or “At Par” will not be accepted. Bank drafts or money orders payable in Canadian funds are probably the best choice.

**Prize List:** An official CKC rosette will be awarded to each dog passing the test.

Only written withdrawals received before Noon, October 17, 2024 will be accepted.

## General Information

- Entries will not be accepted unless accompanied by the appropriate fee. A fee of \$15.00 will be charged on NSF cheques. No post-dated cheques will be accepted.
- Please include all Canadian Tracking Titles earned by the dog on the entry form.
- Entrants are not permitted to train on the test grounds for the 10 days prior to the test. If in doubt, contact the secretary for information about what areas are off limits.

- A random draw of all non-duplicate entries will be held Oct. 17, 2024 at 7:00 pm at 843866 Road 84, Embro, ON N0J 1J0
- Exhibitors must abide by errors made in entering their dogs.
- All dogs must be kept on leash and under control at all times.
- Dogs not officially entered in the Test will not be permitted on the grounds.
- Bitches in season will be allowed to compete but will be assigned the last track.
- Exhibitors should note that the CKC does not confer a title on a dog until it is registered individually in the club's records. An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of The Canadian Kennel Club. The fee will match the Event Registration Number (ERN) fee.
- **Test grounds are located at:** 843866 Road 84, Embro, ON N0J 1J0.
- Test grounds will be open at 8:00 am DST. Drawing for the tracks will commence at 8:30 am DST. Judging will commence at 9:00 am DST with the TD tracks, followed by the TDX tracks.
- Lunch will be served following presentation of awards at the completion of the test.

Directions to the test grounds will be mailed with a confirmation of entry to the test.
