# Judges Biographies

## Conformation

### **Mr Arthur Fry - Australia**



My involvement with dog showing started with Boxers in 1979 when my partner and I founded Lambda Boxers. We have bred and exhibited with success since then, making up 75 Champions for ourselves, with more made up by other exhibitors.

I was also involved in breeding and showing Dogues De Bordeaux from 2003 to 2015, with seventeen champions made up and wins including several Royal Best of Breeds, and multiple Group and In Show awards.

My Championship Show judging started in 1994 with the granting of my Group 6 license, and I have judged groups throughout Australia and New Zealand since then. My progress through the judges training program has culminated with the granting of my All Breeds license in 2014.

I have judged Boxer Specialty Shows throughout Australia and New Zealand, and Boxer bitches at the South Western Boxer Club UK, as well as Bullmastiff Specialties [4], one with an entry of 130, and English Mastiff [twice], Australian Cattle Dog and Kelpie Specialties. I have judged All Breeds throughout Australia, New Zealand, United States of America, Thailand, Philippines and China. In May 2018 I judged bitches and Best in Show at the Central Indiana Boxer Club Specialty Show. Currently I am the Group 6 Coordinator involved in the training of ANKC Judges.

### **Mr Hans van den Berg - Netherlands**



When I was born, Popov, a Scottish terrier stood guard at my cradle and so it's hardly surprising that that breed should have played an important role in my life. I had my first Scottie champion when I was 18 and later on, I bred many champions under the Rymore prefix.

Around 1970 I introduced my first Norfolk terriers at shows. The English imports Ch Nanfan Nova and Ch Ragus Brown Herb were true ambassadors for the breed. I also had a champion chihuahua.

Judging started in 1978 and in the year 2000 the Dutch Kennel Club appointed me as an allrounder.

At the moment, I am judging all over the world. In 2019 I am judging in countries like Estonia, Poland, England (Crufts), Norway, Finland, Germany, Denmark, South Korea, Sweden, Russia, Lithuania, Ireland, Iceland and of course in Holland. I'm very much looking forward coming to Canada again. You have such nice dogs and it is so interesting judging dogs in a country where you are a "stranger".

### **Dr Eric Liebes – Colorado, USA**



Eric's first two dogs were a Komondor and an Ibizan Hound. The Komondor still shares the breed's AKC All-Breed Best In Show record. The Ibizan Hound finished his championship and was one of the first CDX titled Ibizan's.

In the '80's Eric branched out to many Sighthound breeds and also tried his hand at obedience and performance competition. During the 1980's, based out of Denver, he finished championships on dogs of numerous breeds in the family and for others, and placed regularly in the Hound, Working and Herding groups throughout the Rocky Mountain area. He also achieved 7 Komondor National Specialty wins, 10 all-breed Bests-In-Show and finished CD's on five Komondors, two Ibizan Hounds and a Tibetan Terrier.

Eric's first Ibizan Hound was acquired in 1981. By 1994 he had bred a Dual Champion, multiple Best-in-Field, Pedigree Award, and National Specialty winning dog and several other Dual Champions. Eric is still active as an exhibitor and breeder. He has a 7 year old Ibizan Hound and a 5 year old Komondor. Each of these dogs have been Select at their Nationals. With Joan he has shown, bred and finished Samoyeds, including 3 with specialty wins and group placements.

Eric was first approved to judge by the AKC in 1992. His first breed approvals were Ibizans, Greyhounds, and Komondors. He is now approved to judge all Sporting, Hound, Working and Herding breeds, Misc., Junior Showmanship, and BIS. He has judged in Australia, Canada, China, Sweden, Ireland, and Mexico as well as for AKC. He continues to study and learn more about all of the breeds. Eric has had the honor of judging the National Specialty for Greyhounds, Ibizan Hounds,

Kuvasz, Samoyeds and Standard Schnauzers. His goal is to bring a breeder's eye to his judging every time he judges, especially at these important specialties.

Eric is a breed mentor in Komondors, Samoyeds, Greyhounds, Ibizan Hounds and Pulis. He is currently the Judge's Education Coordinator for the Ibizan Hound Club of the United States. Eric and his wife Joan live outside of Colorado Springs with 7 dogs and 2 horses. Eric is retired from his career as a Research Geophysicist for Chevron.

### **Dr Wanda Spediacci – Oregon, USA**



I attended my first dog show in 1967 with my older brother. From the moment I walked onto the field, I knew this was something I wanted to do. From that point on, there was no turning back. We had always had dogs in our home, but the show world became a magical place for me.

I purchased my first Pug and proceeded to finish her championship. As a breeder/owner/handler I found my calling as well as a passion that is lasting my lifetime. With the help of my husband, Bruce, and our daughter, Ann, we continued the Heinzinger prefix on both our Rottweilers and Pugs, and now Cavalier King Charles Spaniels. We showed many dogs to their championships and over the years even managed to keep a few in the top ten.

Our daughter continued the family tradition, like her cousin, in showing in the Jr. Showmanship ring. She and I finished many champions from both breeds. To create well-balanced Rottweilers, we also enjoyed the obedience aspect and earned occasional companion dog titles on our working dogs.

My knowledge of the breeds began in earnest while teaching conformation classes over a ten-year period.

As a member of two all-breed clubs, to local breed clubs our time was pretty much filled with dog activities. I have held every position within an all-breed club and am currently the Secretary and Show Chairman for Richmond Dog Fanciers. This helps to understand the demands of putting on a dog show from both sides of the ring.

Continual education has always been important in our family. Attending seminars and National Study Groups has been a pleasure that I undertake whenever possible. Understanding breed type is the most fundamental element in judication.

Like many others in this sport, exhibiting, breeding and teaching evolved in judging. I was first approved for Jr. Showmanship, then Rottweilers and Pugs. Within four years I was approved for the balance of the Working Group. I am now approved for the Non-Sporting Group and the Toy Group and am 3/4 through the Sporting breeds.

### **Mrs Kathrine Grant - Ontario**



Retired hospital administrator, Manager of the Regional Trauma Program at a large teaching hospital in London, ON. Currently reside on the largest freshwater island in the world, Manitoulin Island

Involved in the sport of purebred dogs since 1976

Bred and showed Irish Setters and Smooth Fox Terriers – bred Irish Setters under the Ballyboy prefix and SFT under both the Ballyboy prefix and Fauxpaw prefix (co-bred with Joe & Janet Lobb)

Owner handled my dogs most of the time with consistent success - #2 SFT in Canada, Group and

BIS wins.

Also owned and showed a Keeshond and Pointers. Currently share life with a Pointer and a Miniature Wire-haired Dachshund.

Judging since 1997 – licensed by the Canadian Kennel Club for All Breeds

A member of the Canadian Dog Judges Association and was the founding secretary of that organization holding the position for almost 10 years; currently serving as a Director at large

Memorable judging assignments include the Ontario All Pointing Breed Specialty Show, Brittany Club of Canada Specialty Show, Chesapeake Bay Retriever Club of Canada Specialty Show, Belgian Shepherd Dog Regional Specialty Show, Rideau Terrier Club and have judged internationally in Australia

Hobbies include quilting, gardening, golf, curling and reading.

## **Mrs Wendy Hamilton-Petkau - Alberta**



The year 1982 marked the beginning of the Auburnmist Golden's, which Wendy is known for today; with her first litter from some top English & American lines. To date, Wendy has produced some Top Winning Golden's in Canada, and multiple Best in Specialty winners, with preferring more English type; Auburnmist Golden's have consistently won under many international Breeder/judges, at various Specialties and All Breed shows. Along the way, Wendy has also owned/co-owned, an English Cocker, and with close friends a Norwegian Buhund, a Skye Terrier & a Australian Shepherd, so I can exhibit for them.

Initially Wendy was only interested in the conformation side of the purebred dog world. After meeting her husband Keith, she changed direction slightly to maintain the intelligence and trainability, the Golden Retriever has become known for. With this change they have also produced many Performance dogs, High in Trial dogs, with 3 of those attaining the perfect 200 score! Keith and Wendy have been entertaining the crowds with their talented Golden's performing with the Spruce Meadows Prairie Dog Agility Team, since 1988.

In 1995, Wendy and her husband Keith opened the Auburnmist Training Centre Inc., a Canine Education Centre for obedience, agility, as well as creating a safe boarding environment for dogs, and of course conformation handling for all breeds of dogs. Wendy has always encouraged new people to learn how to show their own dogs.

Over the years, Wendy has consistently been involved with breed clubs, serving as either an officer or a director. She is presently the President of the Alberta Kennel Club, which organizes Canada's Largest Outdoor Dog Show. With her ties as a leading member of the Spruce Meadows Prairie Dog Agility Group, in 2010, she was instrumental in promoting the Club to move to the #1 World renowned equine venue, Spruce Meadows! Our club became hosts for both the 2013 and 2015, Purina National! Over the years, with addition of many breed/group specialties, the Alberta Kennel Club has become a destination show for many dog enthusiasts, from around the world.

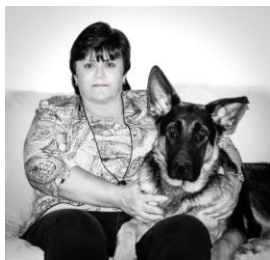
## **Obedience & Rally Obedience Judges**

# Rules and Regulations

## GENERAL INFORMATION AND REGULATIONS

Dogs should be in the building at least one hour prior to ring time. It is the responsibility of the exhibitor to be aware of the posted schedule and be at ringside at the time of judging. The club will not call individual dogs to ringside. Please remain at ringside until judging is completed. Dogs must be exercised in the areas provided, anyone exercising their dogs on the grounds outside the building and not cleaning up after them, will be excluded from the show or trial.

Exhibitors are reminded to respect hospitality facilities. The Red Deer & District Kennel Club reserves the right to refuse future entries from any exhibitor who creates excessive destructive or disruption to host facilities (Hotel, motel or campground). The show superintendent is in complete charge of the shows and trials which, are governed by CKC rules. No judge or any other person participating in any capacity at a dog show held under CKC rules shall be subjected to an indignity of any kind during the progress of the show. The Show Committee has a responsibility to see that this rule is enforced. Chapter 19.7, Page 55, CKC Conformation Show Rules and Regulations.

The Dog Show Committee will use due care and diligence for the welfare of dogs, exhibitors and spectators, but will not be responsible for, nor assume any liability in the event of accident or misfortune. The Red Deer and District Kennel Club reserves the right to remove from the shows or trials any person or dog for any just cause. Any dog excused by the show superintendent or veterinarian, for any reason, shall not compete in any classes or accept any awards for the duration of the shows or trials. No refund of any fees will be made.

If because of riot, civil disturbance, or any other acts beyond the control of the show committee, it is impossible to open or complete the show, no refunds shall be made!

## EXTRACTS FROM THE DOG SHOW RULES - BREEDS, CLASSES, AWARDS AND STAKES

### CHAPTER 4 – JUDGES

It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

**Attention Foreign Exhibitors:** Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you pay by credit card, bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated.

To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept any entry reaching our Show Secretary after the closing time and date.

**Please allow ample time for delays in the mail.**

**Exhibitors Please Note:** An exhibitor has the right to withdraw an entry at any time up to the closing date and time as published in the premium list. This may be done by telephone but **written or electronic notification must be received by the show secretary not later than closing date and time.** If written or electronic notification is not received, the dog will remain entered in the show.

**Entry fees will be refunded when a bitch entered in Rally/Obedience comes into season** after the close of entries if a Veterinarian's Certificate (certifying that the bitch was in season within the 10 day period preceding the trial) is delivered to the Show Secretary **before the starting date and the time of the trial.** The Red Deer and District Kennel Club will refund entry, recording and listing fees if the above conditions are met. No Refunds will be given for the service fees provided by the dogshow.ca

**A 50% refund of entry fees only will be made for a bitch in season without a Veterinarian's certificate with written notification presented to the Show Secretary at least ONE HOUR before the start of the Trials. The bitch must be available to be examined by the Show Superintendent to verify she is in season.**

**There will be no refunds on duplicate entries or overpayments.**

### **Eligibility to Compete in Obedience & Rally Obedience**

To be eligible to compete in these trials, the dog must be 6 months of age and registered or be eligible for registration with the CKC, have an ERN, PEN, CCN or a CKC Miscellaneous Certificate number. A dog may be spayed, neutered or debarked. Only approved CKC approved collars will be allowed in the precincts of the Trials. Correct information on the entry form is the responsibility of the entrant. However, Exhibitors incorrectly entered in the "A" class are permitted to move the dog to the corresponding "B" class up to one hour before the start of the trial. The YKC takes no responsibility for omissions or errors made on the entry forms. The Show Committee and Event Secretary reserve the right to refuse any entry subject to the CKC rules.

**BITCHES IN SEASON** are not allowed to compete in Obedience or Rally Obedience. Entry fees WILL be gladly refunded to exhibitors IF a dated veterinarian's certificate stating that the bitch was in season within a 10 day period preceding the trial is provided to the Show Secretary on or before the date of the trial.

### **LIMITED ENTRY (OBEDIENCE / RALLY)**

Entry in each trial will be limited to the capacity of the judge to perform 7 hours (420 minutes) of judging at the rate of 8 Novice dogs per hour, 7 Open dogs per hour and 6 Utility dogs per hour. Once a judge has reached their maximum capacity the entries shall be closed but a reserve list will be created. Handlers will be notified of their position on the reserve list and any entries pulled after closing date due to a bitch coming in season. Their spot may be filled by a competitor on the reserve list up to and including the day of the trial.

## Championship Points

A dog awarded Winners at a conformation show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded Winners shall be as provided here under.

The schedule to be employed in the determination of the number of points awarded Winners shall be as follows:

*Dogs Competing	1	2	3 to 5	6 to 9	10 to 12	13 & More
Points Allocated	0	1	2	3	4	5

\*Includes the dog awarded Winners

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points.

If a dog awarded Winners is also awarded Best of Breed at the show, then all dogs competing in the breed, including Specials Only, shall be included in the total.

If a dog awarded Winners is also awarded Best of Opposite Sex to Best of Breed, then all dogs of the same sex including those competing in Specials Only shall be included in the total.

If a dog awarded Winners is also awarded Best of Winners, then all dogs defeated directly or indirectly in the breed shall be included in the total.

If a dog is awarded Winners only, then all the dogs of the same sex in the class competition shall be included in the total.

The number of championship points to be credited to a dog awarded Winners shall be determined by the highest award earned and calculated as per this section.

Clarification:

Example of directly or indirectly defeating: If the Winners Bitch is awarded Best of Opposite Sex but not Best of Winners, the Best of Winners Dog shall be deemed to have indirectly defeated the Specials bitches, and is thus entitled to add them to the number of dogs and bitches defeated.

In addition to championship points allocated at the breed level, a dog awarded Best of Breed that also places in the regular group competition shall be credited with the following additional points provided that a dog was defeated at the group level.

A dog may not be credited with more than five (5) championship points in a single show.

Permission shall be granted a club or clubs to hold shows in such a way that any dog may earn three (3) sets of championship points on the same day, provided that one or more of those sets of points is awarded at a specialty for that breed or group.

A dog awarded Winners that also places Best in Show at an all-breed conformation show shall be credited with five (5) championship points inclusive of any points earned at the breed and group level.

In order for a dog to be recognized as a champion and its owner provided with a championship certificate, the dog must: earn at least 10 championship points under at least three (3) different judges;

be registered in the records of the CKC, have an Event Registration Number (ERN) or have a Miscellaneous Certification Number (MCN);

have earned at least one 2-point win either at the breed or group level.

The Board interprets the words "earn at least 10 championship points under 3 different judges" to mean:

Three (3) or more Winners awards at not less than three (3) different shows, under three (3) different judges at the breed level;

each of the three (3) judge's awards must be one or more championship points won at Winners, Best of Winners, Best of Breed or group placing;

all points required for championship status may be earned at Winners, Best of Winners, Best of Breed or group placing.

## **Grand Champion (GCh) Point Schedule**

The title of Grand Champion may only be earned after the completion of the CKC conformation championship.

Points for this title are only accumulated after the completion of the conformation championship and do not include the points earned in attaining the conformation championship.

To be awarded a Grand Champion title, a dog must attain a minimum of 20 points, which must include a minimum of two (2) wins of at least two (2) points each. Points may be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward.

### **Grand Champion Point System**

Points towards the Grand Champion title, at breed level, are awarded to the Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch. Points are calculated based on the number of animals competing at the breed level for the Best of Breed winner and the number of similar-sex dogs competing for the other three (Best of Opposite, Select Dog, Select Bitch). The following schedule shall be employed in the determination of points awarded at breed level:

Best in Show (5 points)

In order to obtain a Grand Champion title, a dog must obtain at least two (2) points after 12 months of age.

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points.

The title of Grand Champion shall not be awarded retroactively and all points towards this title must be achieved after the date of January 1, 2013.

## **Grand Champion Excellent (GChEx) Point Schedule**

The title of Grand Champion Excellent may only be earned after the completion of the CKC grand championship title.

Points for this title may be accumulated at any time after the completion of the CKC grand championship but does not include the points earned in attaining the conformation championship or the grand championship.

A minimum of 100 points, which must include one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed) or a Best in Multiple-Breed Specialty with at least three (3) breeds represented plus three (3) Group 1st or three (3) breed specialty wins.

### **Grand Champion Excellent point system**

Win	Points
First in Group or Best in Specialty Show	5
Second in Group of Best of Opposite Single-Breed Specialty Show	4
Third in Group	3
Fourth in Group (Note: No points are acquired if no other dog is present in the group.)	2
Best of Breed (To earn the breed point, at least five (5) dogs must be shown at breed level.)	1
Best in Show or Best in National Specialty Show	10

Only the highest points earned at a single show are carried forward. For example, a dog that wins first in group and then wins Best in Show, earns 10 points, not 15. The title of Grand Champion Excellent shall not be awarded retroactively. However, dogs that have been awarded the Grand Champion title prior to January 1, 2013, will be awarded the Grand Champion Excellent title on application to the CKC. Additional Requirements To attain a Grand Champion Excellent title, a dog must have been awarded a CKC performance title from any CKC event. A CGN, Herding Tested certificate or Chase Ability Program title are not considered performance titles for the awarding of this.

## **Conformation Classes Offered:**

Regular official classes at a CKC conformation show shall be as described in (a) to (k) of this section. All classes must be divided by sex (except for Specials Only). Only dogs entered in one of the regular, non-regular, or unofficial classes shall be allowed within the show precincts.

**JUNIOR PUPPY:** shall be for dogs at least six months of age and under nine months of age on the day of the show.

**SENIOR PUPPY:** shall be for dogs 9 months of age and under twelve (12) months of age on the day of the show.

**12-18 MONTH:** for dogs over 12 months of age but under 18 months of age.

**CANADIAN BRED:** shall be for dogs born in Canada, Champions of any country excluded

**BRED BY EXHIBITOR:** shall be for dogs owned and handled in the ring by the Breeder. The handler must be the owner/co-owner AND breeder/co-breeder of the dog. The owner/breeder must handle the dog in this class, but need not handle the dog for further awards.

**OPEN CLASS:** shall be for all dogs.

**SPECIALS ONLY:** is for dogs which have a recorded CKC Registration or Event Registration Number and have attained the required points for Championship status including at least one 2 point win either at the breed or group level. Should a dog which is entered in this class be found either not to be registered or has not completed the requirements for Championship status, all awards earned at the show will be cancelled. Dogs entered in this class will compete for Best of Breed, Best of Opposite Sex and Best Puppy if eligible.

### **UNOFFICIAL/NON-REGULAR CLASSES OFFERED**

**BABY PUPPY:** Dogs 3 months of age and under 6 months of age on the day of the show. The award for this class are: Best Baby Male and Best Baby Female Best Baby Puppy in Breed Best Baby Puppy in Group Best Baby Puppy in Show

**VETERAN:** In this optional class for All Breed Shows, dogs must be 7 years of age and over on the day of the show. Dogs entered in this class may be spayed or neutered. The awards for this class are: Best Male Veteran and Best Female Veteran, Best Veteran in Breed, Best Veteran in Group, Best Veteran in Show. A Veteran awarded Best Veteran in Breed is not required to stay to compete for Best Veteran in Group. A Veteran awarded Best Veteran in Group is not required to stay to compete for Best Veteran in Show.

**BRACE:** At an all-breed or specialty show a club may, but is not required to, offer a Brace Class. This class shall be for 2 dogs of the same breed (not necessarily of the same sex). A Brace should be judged as an identical pair – same colour, size, gait, and same stride. When viewed from the side they should appear as one dog and its shadow. A brace must be handled by 1 person on 1 lead.

### **OBEDIENCE CLASSES**

Obedience Ring Size will be 40 X 50. Order of judging will be determined at the close of entries.

No dog may be entered in both Novice "A" and Novice "B", Open "A" and Open "B" at the same trial. In determining class eligibility, if a dog shall have won a particular title before being entered or moved up, the handler shall have been notified by at least 2 different judges that the dog has won 3 qualifying scores for the required title. (However, a dog may continue to be exhibited for 60 days in a class after winning a particular title.) Dogs fulfilling the requirements for a title may be moved to the next level of competition if the schedule permits. The transfer must be on the appropriate move-up form and submitted to the show secretary at least 15 minutes before the start of the class.

**PRE-NOVICE:** The Pre-Novice class is an elective class and earning the title is not a requirement to enter Novice classes. The Pre-Novice class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of P.C.D. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 5 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercise. Only dogs that have not earned the title of C.D. may enter the Pre-Novice class.

**NOVICE A:** The Novice A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of C.D. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. No person who has trained or exhibited a dog that earned a C.D.X. title shall be allowed to handle a dog in this class.

**NOVICE B:** The Novice B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of C.D. Dogs in this class may be handled by the owner or any other person. The owner or any other person may handle a dog in this class. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises.

**NOVICE C:** The Novice C class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title C.D. or any higher obedience titles. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises. Dogs may compete in Novice C indefinitely. Scores earned by dogs in the Novice C class not eligible for High In Trial and do not qualify a dog for any title. Dogs may be entered in the Novice C class in addition to any other official or unofficial classes for which they are eligible.

**NOVICE INTERMEDIATE:** The Novice Intermediate class is an elective class and earning this title is not a requirement to enter the Open classes. The Novice Intermediate class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned a C.D. or any higher obedience trial titles. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle the dog in all 6 exercises. Dogs may compete in the Novice Intermediate class indefinitely. Scores earned by dogs competing in this class are not eligible for High in Trial. Dogs may be entered in the Novice Intermediate class in addition to any other official or unofficial classes for which they are eligible.

**OPEN HA:** The Open HA class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D. but has not earned the title of C.D.X. The handler of any dog in this class must be the owner, co-owner or member of their immediate families. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. Any person who has trained or exhibited a dog that has earned a U.D. title may not handle a dog in this class. Group exercises in Open HA are out of sight as before in the original open classes.

**Open18A:** The requirements are the same as Open HA and the same rules except the Long Sit is replaced with Change of Positions Exercises and the Long Down is replaced with a Group Sit-Walk around.

**Open 18B:** The requirements are the same as Open HB and the same rules apply except the addition of the new Change of Positions Exercises. As described in the Open HA and Open 18A classes

**OPEN HB:** The Open HB class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D. Dogs which have earned the title of C.D.X. or any higher titles may enter in the Open B class. A dog may also be entered in the Utility Class



in the same trial. Dogs in this class may be handled by the owner or any other person. A person may enter or handle more than one dog in this class. The same handler must handle each dog in all 7 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises. Prior to the start of judging, the judge will choose which of the six numbered routines is to be performed. This choice will not be disclosed to the exhibitors until it is posted at ring side at least 30 minutes before the start of the class. In future assignments, judges are required to alternate the six routines so that each set will be used approximately the same number of times. Group exercises in Open HB are out of sight as before in the original open classes.

**UTILITY A:** The Utility A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D.X. but has not earned the title of U.D. Any person who has trained or exhibited a dog that has earned a M.O.T.Ch. title may not handle dogs in this class. The handler of any dog in this class must be the owner or member of their immediate families. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises.

**UTILITY B:** The Utility B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D.X. or U.D. Dogs in this class may be handled by the owner or any other person. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. Prior to the start of judging, the judge will choose which of the six numbered routines will be performed. This choice will not be disclosed to exhibitors until it is posted at ring side at least 30 minutes before the start of the class. In future assignments, judges are required to alternate the six routines so that each will be used approximately the same number of times.

### **RALLY OBEDIENCE CLASSES**

#### **Rally Obedience Classes:**

Ring Size will be 40x50. The precincts of these trials are the ring and immediate area surrounding. Only dogs entered are permitted within the precincts of the trial. Order of judging will be determined at the close of entries.

The following classes will be offered in each Rally Obedience trial: Rally Novice A, Rally Novice B, Rally Intermediate, Rally Advanced A, Rally Advanced, B, Rally Excellent A, Rally Excellent B. Rally Master

**RALLY NOVICE A:** Dogs competing in this class may not have earned the R. N. title or any CKC Obedience title other than P.C.D. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. All exercises are judged on leash, and all dogs must enter and leave the ring on leash.

**RALLY NOVICE B:** Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged on leash, and all dogs must enter and leave the ring on leash.

**RALLY INTERMEDIATE:** The Rally Intermediate Class is an elective class and earning the title is not a requirement to enter Rally Advanced Classes. (CKC rules, 10.1.2) This class shall be for dogs that have earned the R.N. title. A dog completing the R.I. or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. This class (performed on leash, no jumps, no A or B division) may be entered indefinitely. Judges would ordinarily use the same course for it as for their Advanced Classes, substituting one other exercise for the jump required in Advanced.

**RALLY ADVANCED A:** This class shall be for dogs that have won the Rally Novice (R. N.) title but have not won the Rally Advanced (R. A.) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title. All dogs must enter and leave the ring on leash.

**RALLY ADVANCED B:** This class will be for dogs that have earned the R.N. title. A dog completing the R.A. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash. All dogs must enter and leave the ring on leash. No dog may be entered in both Rally Advanced A and Rally Advanced B at any one trial.

**RALLY EXCELLENT A:** This class shall be for dogs that have earned the R. A. title, but have not earned the R. E. title or any CKC Obedience title other than P.C.D. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. All exercises are judged off leash. There is also a sit stay exercise after the finish sign. All dogs must enter and leave the ring on leash.

**RALLY EXCELLENT B:** This class will be for dogs that have earned the R.A. title. A dog completing the R.E. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash. There is a sit stay exercise after the finish sign.

**RALLY MASTER:** This class will be for dogs that have earned the R.E. TITLE . A dog completing the R.M. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class All dogs must enter and leave the ring on leash.

**No dog may be entered in both Rally Excellent A and Rally Excellent B at any one trial.**

**No handler who has exhibited a dog through its C.K.C. Obedience CDX title shall be eligible to enter the A class in Rally Novice, Advanced or Excellent.**

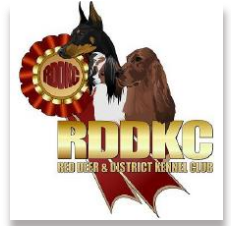
