Shade tents can be set up Friday evening between 5:30 and 7:00 in the outfield, underground sprinkler lines will be marked, **please keep your tent pegs away from the lines!**

### **MOVE UP'S AND DAY OF ENTRIES**

We will be doing move ups between each trial, so there are same day move ups allowed.

We will be taking day of entries if space allows.

Please pick up after dog and yourself, garbage cans will be provided.

Agility obstacles meet the requirements of the CKC agility rules. All contacts are rubber surface and tire is a break away. Wall jump and broad jump will not be used.

There will be no equipment familiarization, but will have a warm up jump.

Manual timing will be used.

- 1. The Club reserves the right to remove any person from the agility trial. The Trial Chairperson shall have full control of the trials, which will be governed by CKC rules.
- 2. Any dog excused by the Trial Chairperson for any reason shall not, after being excused, compete in any class for any award for the balance of the show.

- 3. The trial committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
- 4. A Judge or any person participating in any capacity at this agility trial held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the trial and it shall be the duty and obligation of the Club holding the trial to see that this rule is effectively carried out. The Trial Chairperson shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
- 5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the trial grounds. Be respectful to each other, the volunteers and let us keep each other safe.
