First dog on the line at 6:00 pm sharp Friday and 8:00 AM Saturday/Sunday! Dogs must have an AAC ID card to compete in this trial.

If your dog is under 2 years old or has not had their first measurement, you must have your dog measured, as per the below guidelines:

Measuring

Measuring will be available on Friday at 5:00 pm, Saturday and Sunday at 7:15 AM. All handlers meeting at 7:30 am.

Bitches In Season (BIS)

Dogopogo will be allowing Bitches in Heat to compete at the trial as per AAC Rulebook update v8.7.

Handlers shall notify the trail secretary that they will be running a BIS as soon as it is known. The handler shall minimize exposure of their BIS to other dogs as much as possible. Dogopogo will designate a BIS relief area at the site. All Competitors will be notified if there is a BIS on the site. "BIS" will be noted next to the dog's name on the gate sheet.

Any BIS will run at the end of each class, they shall use a protective mat (the competitor shall provide) on the start line, and are required to wear protective panties at all times except when at the designated BIS relief area (including when running).

All Dogs (including the BIS) will be allowed to withdraw from the trial with a full refund if there is a BIS present.

Clean up

This cannot be said too often!!! YOU MUST pick up after your dog. Anyone seen not scooping will be removed from the trial. No refund shall be given.

Ribbons

Ribbons will be awarded for placements 1st through 4th and there are Ribbons for MADC, ATCHC, Steeplechase, and all of the Bronze, Silver, Gold and Lifetime titles. We also have ribbons for ADC, SGDC, AADC, AGDC and MGDC. Ribbons will not be self-serve - we will provide you with your ribbons at the end of each day.

If you are close to earning a title, please let us know in advance what you are hoping to achieve so we can make sure we have a ribbon available for you.

Move ups

Next day moveups will be allowed - official forms will be available at registration table but MUST be handed to trial secretary ONLY. No Same Day Move Ups.

NOTICE TO EXHIBITORS

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of AAC Rules and Regulations, including, but not limited to, the following:

- This event is held under AAC Rules and Regulations (as of January, 2018) and is open to all dogs being at least 18 months of age, purebred or mixed breed, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance, or dogs showing signs of aggression.
- Obstacles shall be chosen from those described in the current edition of the rules and regulations of the AAC and shall conform to AAC specifications. A breakaway tire will be used.
- No food, or any other aids or devices shall be permitted during a regular run. *Toys (no food) may be used during FEO runs.
- **Collars in the ring - dog will be allowed to wear a close-fitting collar, with no attachments, in the ring.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may be asked to leave the show grounds. In such cases, no refund of fees will be paid.
- All dogs must be kept in their ex pen or crate or on leash when not in the ring. All dogs must be in control when leaving the ring after their run. Any dog engaging in aggressive or out-of-control behavior upon exit of the ring will be disqualified and/or be required to leave the show grounds. In such cases, no refund of fees will be paid.
- Exhibitors must keep crate and all areas clean. Please pick up after yourselves and your dogs.

IT IS EVERYONE'S RESPONSIBILITY

- You must not attend the trial if you are experiencing COVID-19 symptoms or feeling unwell, have been in contact with someone that has the virus. You will be asked to leave the trial site immediately if you are visibly unwell.
- Maintain a minimum 2 meters distance from other individuals at all times: be respectful of other peoples' bubbles!
- Be mindful: avoid unnecessary or inadvertent touching of equipment on course or surfaces anywhere on the trial site
- Bring an adequate supply of masks, gloves and disinfectant for your personal use during the trial
- Anticipate that many of the usual routines we have come to expect at trials are changing. Be gracious and kind in adapting to the 'new normal' of agility trialing. Without changes we will be unable to continue with any trials.

- Remind one another to adhere to the protocols and measures that are in place at this trial to ensure everyone is safe. This is a shared responsibility. Recognize that people may inadvertently slip up and offer a gentle kind reminder.
- If an individual consistently disregards the guidelines, whether inadvertently or intentionally, it is everyone's responsibility to make sure unsafe behaviour is not permitted to continue, since it places everyone at risk. Individuals not complying with the trial protocols and measures may be asked to leave the trial.
