They must have one of the following when submitting the entry form **A)** A full CKC registration number **B)** An Event Registration Number (ERN) **C)** A Temporary Competition Number (TCN) **MUST** be obtained BEFORE ENTERING an event.

**NOTE:** EFFECTIVE JAN 1, 2011 NON MEMBER FEES ARE PAYABLE TO CKC TO TRACK ANY AWARDS FOR HOUNDS WHOLLY OWNED BY NON MEMBERS. CKC WILL CONTACT YOU IF YOU ARE IN THIS SITUATION.
