### **BITCHES IN SEASON (6.10.1 & 6.10.2)**

*BITCHES IN SEASON ARE NOT PERMITTED TO COMPETE. WHEN A BITCH COMES INTO SEASON AFTER ENTRY HAS BEEN SUBMITTED TO THE TRIAL SECRETARY, A VETERINARIAN'S CERTIFICATE, CERTIFYING THE BITCH WAS IN SEASON WITHIN THE 10 DAY PERIOD PRECEDING THE TRIAL, MUST REACH THE TRIAL SECRETARY ON OR BEFORE THE START OF THE TRIAL. THE TRIAL-GIVING CLUB MUST REFUND THE ENTRY FEE, SERVICE CHARGE AND LISTING FEE. THE REFUND AND THE TERMS THEREOF MUST BE CLEARLY STATED IN PREMIUM LIST. UPON PROOF AS PER THE ABOVE RULE ANY BITCH THAT COMES IN SEASON TO INTERFERE WITH THEM ENTERING THE TRIAL, MONIES WILL BE REFUNDED.*
