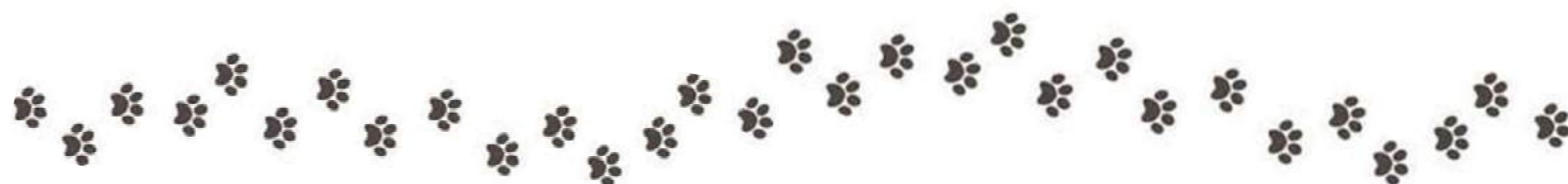

- 3) This is a self clean event. Pick up your dog's waste and dispose of where directed.
- 4) Clean up after yourself.

BE KIND – CKC REGULATION: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating this has occurred.

AWARDS

Qualifying ribbons and New Title rosettes will be awarded to qualifying teams.

REFUNDS

There are NO CREDITS or refunds for anyone wishing to pull their entries after the closing date. Females in season or lame dogs will be excused. If dog is not present for assessment, a note signed by a veterinarian will be required for any refund or credit consideration.

If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to start or to complete this event, no refund of entry will be made.

BITCHES IN SEASON

Females in season may not enter and are not allowed on the event grounds. When a bitch comes into season after the entry has closed, a Veterinarian's note certifying the bitch was in season within the 10-day period preceding the event must reach the secretary on or before the start of the event. A refund of entry fees and listing fees will be given (not the 10% Dogshow program service fee)

ELIGIBILITY

Scent participation is open to all purebred and mixed breed dogs at least 6 months of age that are individually registered with the CKC, or have an Event Registration Number (ERN) or a Performance Event Number (PEN) or eligible for the registration with the CKC or have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed, or have a Canine Companion Number (CCN) if it's a mixed breed.

Signed Agreement Must Be Sent with Entry

I (we) acknowledge the Flat-Coated Retriever Society of Canada (FCRSC) has the right to refuse this entry for cause, which the organizing committee shall deem to be sufficient.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and win ribbons, I (we) agree to hold this club The FCRSC, its members, directors, officers, agents, superintendents, sponsors of the events, or trial secretary, judges, volunteers and the owner or lessee of the premises and any employees of the aforementioned parties harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the trial premises or grounds or near any entrance thereto.

I (we) personally assume all responsibility and liability for any such claim and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death, or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage, injury be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this scent trial, howsoever such injuries death or damage to property may be caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.
