**Day of entries** must be made at least one hour before the start of the trial.  
Exhibition Only (one trial per day) ..... \$ 10.00  
Listing Fee per entry per trial if not CKC reg'd ..... \$ 9.50  
Catalogue, must prepay and pre-order ..... \$ 3.00

All fees include HST and are in Canadian funds. A listing fee is payable if a dog has no CKC individual registration number, an ERN, PEN, or CCN.

**USA Exhibitors** Bank drafts or money orders in Canadian Funds and personal cheques, payable in US funds, for the full amount of the entry will be accepted. Cheques discounted for exchange, marked "Payable in Canadian Funds", or "At Par" will not be accepted.

**LIMITED ENTRY** mean entries will close on the listed closing time or when the Obedience judge's assignment reaches 7 hours of judging when calculated at a per hour rate of 9 Pre-Novice dogs, 8 Novice dogs, 7 Open dogs and 6 Utility dogs. Where Rally is calculated based on the judging of a maximum of 15 dogs per hour. (CKC 4.4.2) *'When the advertised limit has been reached, all remaining entries may be assigned a position (by class) on the reserve list. The person making the entry shall be notified of his position on the list. In the event that the entry of a bitch in season is withdrawn after the closing date, it may be substituted with one from the reserve list up to 24 hours prior to the trial. Fees will not be refunded for any reason other than a bitch being in season and to those on the reserve list who did not participate in the trial.'*

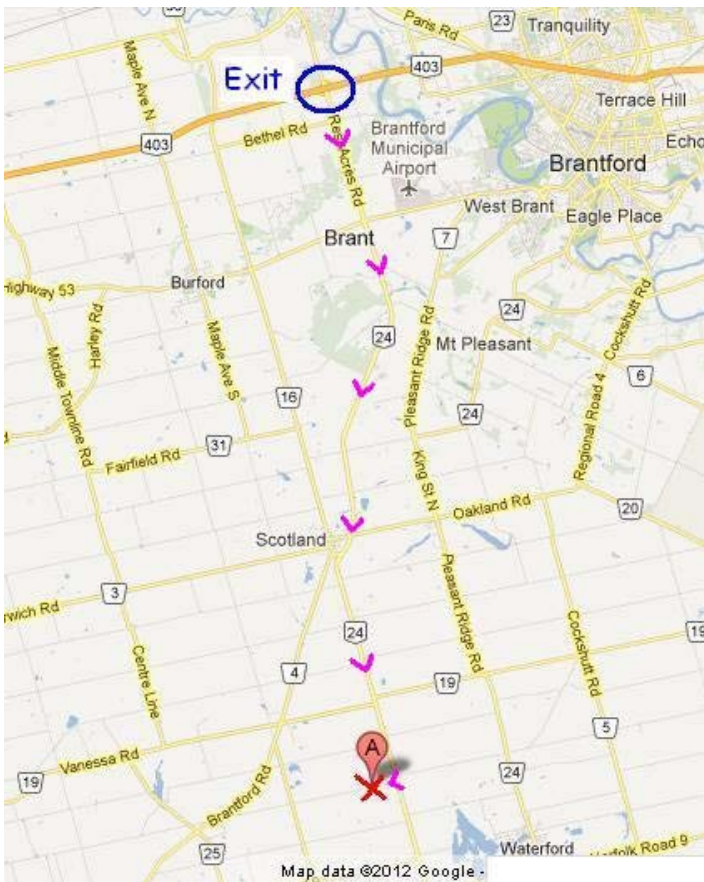
**New Title Rosettes** – The Poodle Club of Canada is pleased to offer a rosette for each dog completing the requirements for a Rally Obedience or an Obedience title at these events.

### **GENERAL INFORMATION**

1. The **trial precincts** shall be the entire building of The Poodle Farm.
2. Show Superintendent has full charge of the show which is governed by CKC rules.
3. The Poodle Club of Canada and The Poodle Farm will use **due care and diligence** for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
4. **Obedience Rules & Regulations. Chapter 20.7 It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience or Rally Trial held under these regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.**
5. **BITCHES IN SEASON** are not permitted to compete. When a bitch comes into season after entries close, a Veterinarian's certificate, certifying that the bitch was in season within ten days of the trial, must reach the Trial Secretary on or before the day of the trial, prior to the judging of the class, and the club will refund the entry fees.

6. **CKC Non-membership participation fee** – i) A non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. ii) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. iii) In order for titles to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. iv) All Premium Lists will carry a note stating that these fees apply only to dogs wholly owned by non-member residents of Canada and are not applicable to CKC members.
7. **Mix Breeds and Unrecognized Breeds** must have a Canine Companion Number (CCN) from the CKC to enter the trials. A dog eligible for a CCN may not be entered as a listed dog.
8. If, because of riot, civil disturbance, or other acts beyond the control of management, it is impossible to open or complete the trials, no refund of Entry Fees will be made.
9. Flexi-leads may not be used on The Poodle Farm property

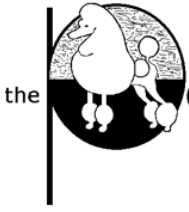
Directions from London:

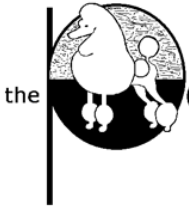
