

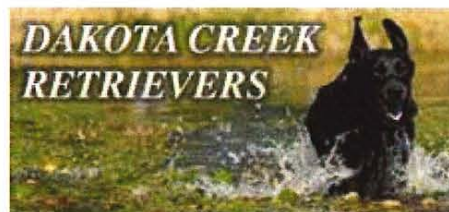

Ducks and/or Pheasants will be used in all stakes.

ARLINE JAMES MEMORIAL TROPHY will be presented to the weekend's all-age high-point amateur handler at the conclusion of the trial.

ROTATION starting numbers for each All Age stake will be based on the two digits right of decimal on the TSX closing, Wednesday August 16, 2023. The subsequent rotation for the 2nd, 3rd and 4th series for the Friday and Saturday All Age stakes will be established prior to the trial and posted at each stake. If a starting number is gone, the next higher number will be used.

NOTICE TO COMPETITORS AND SPECTATORS

Release and Indemnification of Landowners and Alberta Field Trial Club: By entering this event, each participant agrees to assume all risks and hazards incidental to participation in the event and agrees to release, save harmless and indemnify the owner(s) of the property upon which the event is held, together with their agents, employees and representatives from all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to the person, dog, or property of the participant howsoever caused, arising out of or in connection with the participant's use or entry upon the property. It is understood that this agreement is binding upon the participant and all of his heirs, executors and assigns.

RULE 21.7 of the Field Trial Rules States: "It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Retriever Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue."

No training on the trial grounds before, during, or after the trial. Do not make private requests to the Landowners for permission to train. Please adhere to this restriction so as not to jeopardize our club's use of these grounds for our trials in future years.

Stay on established roads and designated areas. Do not drive over open pasture unless instructed by trial committee.

Close all gates, whether they have been left open or not.

While dogs are being tested, please refrain from loud talking or other noises, also from unnecessary motions, all may be distracting and may seriously interfere with the dogs' work. No white clothing in the gallery. Do not applaud until the dog has completed the test and is leaving the line.
