All competitors are invited to attend a Judges’ Dinner on Saturday evening following completion of the Trial – location to be determined.

**Move Ups:**

Move Ups will be allowed providing the Move Up form is received by the Event Secretary 1 hour before the start of the applicable Trial. Move Up forms will be available at the Event Secretary’s table.

All other corrections to entries must be made in writing to the Event Secretary no later than 1 hour prior to the start of the Trial.

### **Limits, Wait Lists and Refunds:**

These events are limited to 125 runs per day. Once the Trial is full, a wait list will be created. When the Trial is full a notice to that effect will be placed on both the Sniff Alberta website and Facebook page. Individuals who submit entries after the Trial is full will be asked if they wish to be placed on a wait list. Day of Trial entries will not be accepted.

Entries withdrawn in writing before the deadline of May 15, 2018 at 9:00 pm MST will be refunded in full. Entries withdrawn after that date will only be refunded if the Trial reaches its maximum entry limit and the entry is filled by a dog from the waiting list. No substitution of dogs will be allowed.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Event Committee. If, because of riots, civil disturbances, or other acts beyond the control of the host organization it is impossible to open or complete the show, no refund of entry fees will be made. If, in the opinion of the Event Committee, the well-being of dogs, exhibitors or spectators is at risk due to extreme weather conditions such as, but not limited to, snow storms, hurricanes, lightning or extreme heat, the host club may cancel or stop the trial before completion, without refund.

### **Volunteers:**

Sniff Alberta asks that exhibitors be willing to volunteer to help with the many positions that will need to be filled in order to make this trial fun and successful for all. More information about volunteer positions will be posted on the Sniff Alberta website and Facebook page closer to the Trial date.

### Information:

**Pre-Trials:** All dogs must earn the Pre-trial (PT) before being allowed to compete at that level in an Individual Element class. Only one pass is required for each level. Dogs that have passed their Odor Recognition Test (ORT) from the National Association of Canine Scent Work (NACSW) are not required to earn a PT for the odor(s) they have passed in NACSW. Proof of Odor Recognition Tests from the NACSW **must be included** with the entry form when entering any trial if the dog has not earned a PT or any other UKC title for odors that will be used in the trial.

**Dogs must be on leash and under control at all times. No dog-dog interactions, please maintain a minimum space of 15 ft. between dogs. Reactive dogs are welcome. We want to provide a positive environment for all participants, and we need your help to play safe! Per UKC rules, aggression will not be tolerated.**

Flat collars or harnesses for searches only. Elimination of team will occur if the dog relieves him/herself during the search.

Bitches in heat are allowed to participate after the last run of the day.

Exhibitors are responsible for being at ring side when it is their turn to run.

The Trial will run regardless of inclement weather. Please bring clothes and dog bedding so you are comfortable in hot, cold, wet or dry weather.

Entering a UKC Nosework Event: Entries to all events for licensed classes must be submitted using the most current official UKC entry form. Entry forms must be complete when submitted to the Event Secretary, including a valid UKC Permanent Registration number, UKC Performance Listing (PL)/Limited Privilege (LP) number or UKC Temporary Listing (TL) number. Incomplete or unsigned entry forms are invalid and will be refused. It is recommended exhibitors begin the process of obtaining a UKC registration number early. \*\*Please note that because Sniff Alberta is holding this trial under a provisional license we are unable to issue Temporary Listing (TL) numbers at this trial. TL numbers can be obtained online here: <https://www.ukcdogs.com/tl-numbers>. Entries must also include a signed Sniff Alberta Photo/Video & Participation Waiver and Release 2018 form.

### Notice to Exhibitors

1. All events are held under the rules and regulations of the United Kennel Club Inc. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport. The current Nosework rulebook is available on the UKC website: <http://res.ukcdogs.com/pdf/ukc-nosework-rulebook.pdf>. A printed copy of the rulebook will be available at the Trial Secretary's table.
2. Absolutely no alcoholic beverages or illegal drugs will be allowed on the grounds or in the buildings on the day of a UKC Licensed event.
3. It is expressly understood that exhibitors alone are responsible for the behaviour of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behaviour may, at the discretion of the Event Committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
4. UKC, Sniff Alberta, Wild West Event Centre, their agents and their employees assume no responsibility for any loss, damage, or injuries sustained by spectators or exhibitors, or to any of their dogs or property, and further assume no responsibility for injury to children not under the control of their parents or guardians. UKC, Sniff Alberta and Wild West Event Centre are not responsible for loss, accidents or theft.
5. The "No Smoking" rule will be strictly enforced in all buildings and areas so designated.

6. Exhibitors and dog owners are expected and required to clean up after their own dogs. Any person witnessing a violation of this rule must report it to the Event Committee. The Event Committee may ask any person violating this rule to leave the event grounds. No refund will be made if an exhibitor is asked to leave the grounds.
7. UKC will vigorously support any motel that files a complaint about exhibitors who fail to keep their dogs quiet or to clean up after them. In order that the bad conduct of a few exhibitors does not spoil it for the majority of responsible exhibitors, UKC will take strong disciplinary action against any offenders.
8. Dogs may not be left unattended when crated in soft mesh crates. No dogs may be left in an unlatched or unzipped crate.
9. Except when being judged or when crated, dogs must be kept on leash.

1. Nosework trials will include a pre-trial for the levels being run. Dogs need to pass the pre-trial for the level they are competing in. Dogs may be entered prior to passing, but must pass the pre-trial prior to competing that day. If the dog has passed on ORT in the applicable odor please submit a copy of proof.
2. Individual element classes are divided into Levels “N”-“E” and further divided into “A” and “B” sections depending on the experience of the dog and/or handler. Be sure to check the rules regarding the divisions. For these classes, dogs will only be searching the elements chosen.
3. Full Nosework Trials are divided into Levels “N”-“E” and further divided into “A” and “B” sections depending on the experience of the dog and/or handler. These trials contain all four elements. Each element passed earns a leg toward a title in that element.
4. Handler Discrimination. One glove will be used and must be provided by the handler.
5. All entries must be submitted on the current “Official UKC® Nosework Trial Entry Form”.
6. Use a separate entry form for each dog entered in a club's event.
7. Nosework events are open to all UKC registered breeds and mixed-breed dogs with a valid Performance Listing/Limited Privilege number/Permanent Registration/Temporary Listing.
8. We want you to keep the points earned at UKC Licensed events. Important things to remember:
  - All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Performance Listing/Limited Privilege number.
  - Dog not UKC registered? Apply for a Temporary Listing Number (TL) online at [www.ukcdogs.com/tl-numbers](http://www.ukcdogs.com/tl-numbers). (TL fees are non-refundable, non-transferable and do not apply to the cost of permanent registration.)
  - All entry forms must be completed and signed. Incorrect information submitted on the entry form may invalidate your wins.

I hereby grant permission to Sniff Alberta, and its officers, volunteers, trustees, employees, agents, students, representatives, successors, licensees and assigns to photograph and/or videotape my image, likeness, or depiction and/or that of my minor children (if applicable) and dogs. I hereby grant permission to Sniff Alberta to edit, crop, or retouch such photographs, and waive any right to inspect the final photographs and/or videos.

I hereby consent to and permit photographs of me and/or those of my minor children and dogs to be used by Sniff Alberta worldwide for any purpose, including educational and advertisement purposes, and in any medium, including print and electronic.
