Go apx 3.5 km's and turn left onto Sunpoke Road. Go 3.5 km's and turn right onto Dewitt Road. #91 is apx 1 km on the left hand side.

Section 18.7 CKC Hunt Test Rules and Regulations

It shall be the duty and obligation of the event giving club to see that a judge, club official, volunteer, or any participant at the hunt test held under these regulations, is not subject to any indignities. The Hunt Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

ATTENTION ALL CANADIANS WHO ARE NOT CKC MEMBERS

Effective January 1, 2011, the CKC has instituted an annual Non-Member Participation Fee for awards and titles. Canadian non CKC member participants must either purchase a CKC membership or pay the non-member participation fee within 30 days of notification or the CKC will cancel any awards and titles.
