Any dog entered in an unofficial Class must also be entered in an official class or exhibition only.

To comply with CKC regulations, we will be unable to accept or substitute any entry reaching the show & trial secretaries after the closing time and date.

All entry fees should be forwarded to our Show Secretary prior to closing date.

Important Note Regarding Emails- it will be the responsibility of the exhibitor to ensure that any electronic submission, either email, or any document transmitted electronically, reaches the proper authority or recipient, within the times and limits as regulated for each document in the CKC Rules & regulations.

The Dog Show Rules states a judge officiating at a show held under these Rules shall not be subjected to indignities of any kind during the progress of the show, and it shall be the duty and obligation of the club holding the show to see that this Rule is effectively carried out.

A copy of the Rules pertaining to Dog Shows & Obedience Trials is available from the Canadian Kennel Club. Each exhibitor is responsible for knowing and complying with the rules of the Canadian Kennel Club regarding their events.

Telephone entries are prohibited except in such circumstances as the Board of Directors of the CKC may otherwise authorize. On line entries and/or credit card payment will be accepted when accompanied by authorized VISA or MASTERCARD and Amex. Customers' charges that are declined will be assessed a service charge of \$25.00.

Incomplete entries or entries received without fees, or entries received after the advertised closing date will not be accepted.

Attention Foreign Exhibitors

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, Your understanding and co-operation is appreciated. Thank-you.

**BORDER CROSSING** - A Rabies Certificate is required to bring a dog into Canada, Government Regulations require a Certificate prior to entry into Canada.

Event Registration Number (ERN) Notice

All dogs that are foreign born and owned and enter Canada for the sole purpose of entering CKC events will require an ERN. An ERN must be obtained within 3 days of obtaining points, awards or scores to avoid cancellation. If factors beyond your control prohibit this or present a problem, please send a written request for a 30 day extension to the CKC. An ERN may be obtained by contacting the CKC at: (416) 675-5511 or Fax (416) 675 -6506.

### **Temporary Competition Numbers**

All dogs entered in CKC events that are not CKC registered must have a Temporary Competition Number (TCN) before entering into the event(s). This includes Baby Puppies in Conformation shows. Please note that Listed Breeds are not eligible for a TCN (effective July 6, 2021, this includes Baby Puppies). Listed Breeds must have a Miscellaneous Certification Number (MCN) before entering into an event. The Conformation Show Rules will be updated in this regard.

### **Non-member participation fee**

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled
- c) These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members."

### **EXTRACTS FROM CONFORMATION SHOW RULES & REGULATIONS**

**4.7.1** A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty, and obligation of the club holding the show to see that this rule is effectively carried out

**19.7** It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this copy of this regulation shall be prominently placed in every premium list and catalogue.

### **Show Officials 5.1.6**

The officials of a show-giving club will be held responsible for the conduct of exhibitors and spectators during the show. Any person acting in an objectionable manner must be removed from the show on complaint to the Show Superintendent.

### **ENTRY FORMS – SECTION 8.2.3**

Entry forms received by the CKC that are incomplete and/or contain incorrect information may result in awards being cancelled.

### **ENTRY FORMS – SECTION 8.2.5**

An error in an age-specified class, the class, date of birth or sex may be amended on the entry form up to one hour before the start of the show.

### **ENTRIES - SECTION 8.3.1**

Every dog entered in a conformation show must be one of the following:

- a. registered with the CKC
- b. have an Event Registration Number
- c. eligible for registration with the CKC, or
- d. if it belongs to a listed breed, it must have a Miscellaneous Certification Number (MCN)

### **REFUSAL OF ENTRIES – SECTION 8.6.2**

A Club may refuse any entry form from an exhibitor known to have tendered a dishonoured cheque or declined credit card unless entries are accompanied by cash, money order or certified cheque.

### **DISQUALIFICATIONS – SECTION 14.1.4**

Once a dog has been disqualified for any reason at a conformation show, it may not be entered or shown at another show until the dog has been reinstated by the CKC. All awards earned by the dog shown in violation of this section will be cancelled by the CKC and the owner of the dog is subject to disciplinary action.



A service charge of 10% will be assessed. This includes entries sent online or post using a credit card or Interac for payment.

## CHAMPIONSHIP POINTS

15.1.2 The schedule to be employed in the determination of the number of points awarded Winners shall be as follows:

Dogs Competing*	1	2	3 - 5	6 - 9	10 - 12	13 +
Points Awarded	0	1	2	3	4	5

\*Includes the dog awarded Winners

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points.

15.1.8 In addition to championship points allocated at the breed level, a dog awarded Best of Breed which also places in the regular Group competition shall be credited with the following additional points provided that a dog was defeated at the Group level.

15.1.9 A dog may not be credited with more than five (5) championship points in a single show.

15.1.10 Permission shall be granted a club or clubs to hold shows in such a way that any dog may earn three (3) sets of championship points on the same day, provided that one or more of those sets of points is awarded at a specialty for that breed or group.

15.1.11 A dog awarded Winners that also places Best in Show at an all-breed conformation show shall be credited with five (5) championship points inclusive of any points earned at the breed and group level.

15.1.12 In order for a dog to be recognized as a champion and its owner provided with a championship certificate, the dog must: (a) earn at least 10 championship points under at least three (3) different judges; (b) be registered in the records of the CKC, have an Event Registration Number (ERN) or have a Miscellaneous Certification Number (MCN); (c) have earned at least one 2-point win either at the breed or group level.

15.1.13 The Board interprets the words “earn at least 10 championship points under 3 different judges” to mean: (a) Three (3) or more Winners awards at not less than three (3) different shows, under three (3) different judges at the breed level; (b) each of the three (3) judge’s awards must be one or more championship points won at Winners, Best of Winners, Best of Breed or group placing; (c) all points required for championship status may be earned at Winners, Best of Winners, Best of Opposite Sex, Best of Breed or group placing.

**15.2 Grand Champion (Gch) & 15.3 Grand Champion Excellent (Gchex) Rules**

CONFORMATION The following classes will be provided, divided by sex.

**REGULAR CLASSES:** The following CKC Regular Classes will be provided for both sexes:

**JUNIOR PUPPY** - 6 months & under 9 months on the day of the show

**SENIOR PUPPY**- 9 months & under 12 months on the day of the show

**12-18 MONTH CLASS** - for dogs 12 months of age and under 18 months of age on the day of the show

**CANADIAN BRED** - for dogs born in Canada, Champions in any country excluded.

**BRED BY EXHIBITOR** - shall be for dogs owned and handled in the ring by the breeder.

**OPEN CLASS** - shall be for all Dogs Open (Divided by Weight): under 15lbs, 15 - 20 lbs, 20 - 25lbs

**VETERANS CLASS**- Dogs 7 years of age and over on the day of the show. This class may, at the discretion of the club, be divided by age into not more than three age divided classes. Veterans do not compete for points but Go Directly to Best of Breed. Dogs entered in these classes may be spayed or neutered. .

**SPECIALS ONLY** - A dog may be entered for “Specials Only” and such dog shall compete for Best of Breed award. If eligible it must compete for the award of Best of Opposite Sex. All awards the dog earned at the show will be cancelled if, at the time of closing of entries for the show, the dog was not registered individually in the records of the Canadian Kennel Club or if the dog has not earned all the championship points required for championship.

**NON REGULAR CLASSES :**

**BABY PUPPY CLASS DOGS:** 4 months of age and under 6 months of age on the day of the show.

**BRACE**- At an all-breed or specialty show a club may, but is not required to, offer a Brace Class. This class shall be for 2 dogs of the same breed (not necessarily of the same sex). A Brace should be judged as an identical pair - same colour, size, gait, and same stride. When viewed from the side they should appear as one dog and its shadow. A brace must be handled by 1 person on 1 lead

**STUD DOG & GET** -shall be comprised of the stud dog and 2 or more of his get. Ownership in this class need not be identical. The stud dog may be spayed/neutered and must be entered in a Regular class or in Exhibition Only. Get must be entered in a Regular class. ments as the Stud Dog and Get class

**BROOD BITCH & PROGENY**- This class shall have the same requirements as Stud dog and get

**EXHIBITION ONLY** - Dogs entered in this class may not compete in the regular breed classes.

Shall be for any dog 6 months up to but not including 18 months of age. To enter this class, the dog must be entered in one of the CKC regular classes or in Specials only. There will be Four classes in all, divided by sex.

- Junior Class for Dogs at least 6 months of age up to but not including 9 months.
- Senior Class for Dogs at least 9 months of age up to but not including 12 months.
- 12-15 Open for Dogs at least 12 months of age up to but not including 15 months.
- 15-18 Open for Dogs at least 15 months of age up to but not including 18 months.

The winners of all six classes will compete for Best in Sweepstakes. A rosette will be awarded to first, second, third and fourth places in each class as well as to Best in Sweeps and Best Opposite Sex in Sweeps

- 25% of the total sweeps entry fees will go to the Best in Sweeps and rosette
- 10% of the total sweeps entry fees will go to the Best Opposite Sex in Sweeps and rosette

Junior handling is open to all persons from ages 4 up to 18 years of age on the date of competition. All Dogs must also be entered in the regular classes at the all-breed show, but need not be owned by the junior or any of his immediate family.

A rosette and suitable prize will be awarded to the winners of First in each class, flat ribbons will be given to 2nd through 4th in each class.

PeeWee handlers will receive a Participant ribbon and prize.

A rosette and prize will be offered for Best Overall.

**Section 3.4.1** “Junior Handler with the exception of PeeWees, must apply to CKC Head Office on the appropriate form for a Junior Handling Number within 30 days of competing in their first Junior Handling event. This Junior Handling Number will be used by the Junior Handler for the duration of their Junior Handling career. If a Junior Handling number is not obtained, Junior Handling points earned will not be tracked.”The Application For Junior Handler Number is posted on the CKC website under theEvents tab, and thenUnder Event Forms, Exhibitor, or Event Supplies, Junior Handling. **The application can be mailed, faxed, or e-mailed to CKC Head Office and there is no fee.**

## **GENERAL INFORMATION**

- The Show & Trial Superintendent will be in full charge of the show, which will be governed by CKC rules.
- Children, accompanied by an adult, are welcome at our show, however, please do not allow them to disturb dogs without permission of owner/handler.
- All exhibitors will be held responsible for clean up on the show premises and surrounding areas for their own dogs or dogs they are handling and must use the designated areas.
- It is the responsibility of the exhibitor to have their dog at ringside when it is scheduled.
- A judge officiating at a show shall not be subject to indignities of any kind during the progress of the show and it is the duty and obligation of the show-giving club to see that this rule is effectively carried out. (Dog Show Rules, Sec. 4.1.3)
- No person may approach a judge, either directly or otherwise, orally or in writing, to favor his entry. Disciplinary action will be taken against any person who violates this rule or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the act. (Dog Show Rules Sec. 4.1.6)
- Fraser Valley Dog Fanciers and the Show Committee will use care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume and liability in the event of an accident, or other misfortune to either the dogs or exhibitors or patrons. If, because of riot or civil disturbance or any other acts beyond the control of the BTCC and their Show Committee, it is impossible to open or close the shows, no refund of entries will be made.
- Only dogs entered in the Shows & Trials will be permitted on the show premises.
- The precincts of the show shall be the areas designated where the shows and trials are being held within Heritage Park.



## GENERAL RULES GOVERNING THESE SHOWS

It is the responsibility of the Exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the Conformation Rule book are available from the CKC, 400 200 Ronson Dr., Etobicoke, ON M9W 5Z9

-----

1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules.
2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
4. A Judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
6. **DOGS MUST BE READY FOR JUDGING.** The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed
7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$50.00 plus GST which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog **BEFORE** taking it to the Judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
11. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.
13. The Club has a zero tolerance of abuse of any description involving any person involved with these shows, including spectators.
