Limited Available Power in Unreserved Benching area is \$100 Cash, limited outlets available, first come first served.

Requests for power will be taken by an AKC member at the Show Secretary desk at 2pm.

Please Note** No vehicles will be allowed into the building for setup or take down**

Please ensure you have carts to move your items in and out of the building.

Building Hours:

6:00 a.m. on Friday, Saturday and Sunday and will close at 11:00 p.m. Thursday, Friday, and Saturday. Spruce Meadows Equiplex must be vacated by 6:00 p.m. on Sunday.
