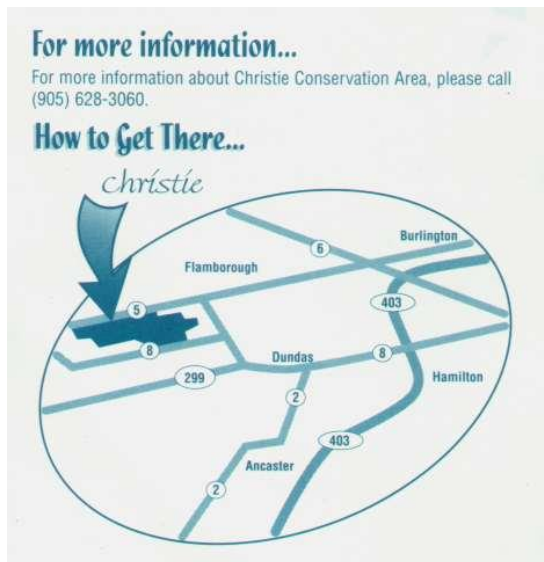

- Standard CKC Rosettes awarded to all qualifying dogs at the Tailgate on Saturday night
- Sunday rosettes will be awarded at the completion of each stake
- Game birds will be used
- Shotguns may not necessarily be used
- All handlers **MUST** wear dark or camouflage clothing
- Refunds will be given for bitches in season. A veterinarian certificate must be submitted before the start of the test
- Separate entry forms **MUST** be completed for each test
- Handlers may be required to handle a gun during the test. Gun safety is considered part of the test

IMPORTANT NOTE regarding Non-Member Participation Fee (effective January 1, 2011)
