Rally Obedience judging is based on 15 dogs/hour plus 10 min walk through time.

Exhibitors are advised to check judge's sheets when posted and to immediately advise of any inaccuracies.

It is the exhibitor's responsibility to know the rules pertaining to show and trials.

Junior Handling Obedience will be at lunch break both days.
