GENERAL INFORMATION: If the dog entered does not have C.K.C. number, it WILL have to be registered online and the ERN number obtained upon registration will be indicated on the TD/TDX trial registration form.

U.S. entrants may pay fees by money order made payable in Canadian funds or personal cheque in U.S. funds for the full amount of the fee(s). Personally discounted cheques will not be accepted. Please DO NOT mark cheques "Payable in Canadian Funds" or "at par" as these are not readily cleared by the banks.

Tendering an NSF or post-dated cheque will be considered as non-payment of fee(s) and will subject the maker of the cheque to a \$15.00 "handling fee" and disciplinary action. (C.K.C.)

The entry of a dog with a Temporary Competition Number (TCN) at a tracking test held under these rules (sanctioned tracking tests excluded) must be accompanied by a TCN fee of \$10.50, which will be submitted to the CKC within 21 days after the event. <https://www.ckc.ca/en/Files/Forms/Shows-Trials/Exhibitors/Non-Member-Participation-Fee-Form-Form-No-150-00-5>

Due to the limited entry we shall be accepting entries with only one entry per submission. **Mail, Courier, or Hand Delivery, with only one entry per event. No EXCEPTIONS!** Entrants will be notified by phone or email that their entry has been received. Entry fees will be returned within 10 days of the day of the test to Alternates who did not participate in the test.

DRAW FOR ENTRY: A random drawing of all entries received by the closing date and time will take place to determine placement in the test or onto an Alternate list. The drawing will be at 7:00 p.m. on Friday, February 21, 2020 at 5032 McMath Street, Abbotsford, B.C. As per CKC 6.6.3 the position of the exhibitor in the test, or on the alternate list will be provided within 24 hours of completion of the entry draw.

MEETING PLACE AND DRAW: Rendezvous is scheduled for 7:15 a.m. at **Campbell Valley Park, South entrance, 8th Ave and 204 St, Langley BC, Canada** 1st parking lot, where the **draw for tracks** will take place. Any primary entrant(s) who is absent at this time will forfeit their position to the first Alternate present. BITCHES IN SEASON may compete, however, they will run last. Please advise the Test Secretary upon arrival.

LIABILITY: All entrants must acknowledge that they are ultimately responsible for their dog's safety and well-being at a test. A waiver form will be signed by owners/handlers.

AWARDS: Tea and coffee will be offered following the tracking test at which time the Judge will present ribbons to all the successful teams.

REFUNDS: When an entered dog is withdrawn after the closing date, refunds will only be permitted when the vacancy is accepted by an "Alternate". If a position becomes available, Alternates will be contacted in catalogue order and asked to either accept or decline the position. (i.e. if #1 declines #2 will be contacted, etc.) RULE 14.7: It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

A printed catalogue listing each entered dog and each alternate will be provided to each team on the day of the test. A copy of CKC Tracking-Test-and-Regulations will be available for reference on the day of the test.

It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
