DIRECTIONS TO SITE – 91 DEWITT ROAD, RUSAGONIS, NEW BRUNSWICK

From Fredericton: Follow the Hwy 101 until Hwy 655. Turn left onto Waasis Rd, go apx. 3.5 km's and turn right onto Wilsey. Go through covered bridge turning left onto Rusagonis Road. Go apx 3.5 km's and turn right onto Sunpoke, another 3.5 km's and turn right onto Dewitt. Tests are at #91 Dewitt Road, Rusagonis, NB, apx. 1 km on left.

From Saint John/Oromocto/Moncton: Follow the Trans Canada until exit 297. At the end of the ramp, turn past the Irving Big Stop and go to the end of the Road. Turn right, go 1.3 km's and turn left onto Rusagonis Rd. Go apx 3.5 km's and turn left onto Sunpoke. Go another 3.5 km's and turn right onto Dewitt. Tests are at #91 Dewitt Road, Rusagonis, NB, apx. 1 km on left.

The Hunt Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred
