FD, FDA and FDX gunning will be done by official Gunners. Call-back may be permitted in any test, upon discretion of Judges.

Handlers in all tests must carry a starter's pistol.

These are Licensed Tests Open to All CKC Recognized Pointing Breeds. These events are held under the rules of the "Canadian Kennel Club". Note: A Temporary Competition fee as established by the Canadian Kennel Club must accompany the entry of a dog for which a Canadian Kennel Club individual registration number (ERN), Performance Event Number (PEN) or Miscellaneous Certification Number (MCN) is not shown on the entry. form. Visit the CKC website for more details. Choose 'listed' on the registration form to indicate you are paying this amount. All entries will be confirmed and you will be advised of the running order prior to the test

### Other Things You Should Know

- These tests are held under the rules of the Canadian Kennel Club, all Participants are expected to familiarize themselves with the rules. Rulebooks are available from the CKC
- Entries are limited to the number of dogs that can be run during available daylight hours. Any entry may be cancelled without penalty before the closing.
- Entries scratched after the closing must still pay their full entry fee & listing fee if applicable. Failure to do so within 7 days of the test will be considered non-payment of fees.
- Withdrawals of entries before or after the drawing must be made with the Field Test Secretary only.
- The drawing will be done at random. We will not pre-assign any participant aspecial place in the running order.
- You are welcome to e-mail about your dog's position in the running order; however, we cannot guarantee the time of day any entry will run. It is the handler's duty to have his / her dog ready in place when required for judging.
- There will be **NO** training of dogs anywhere on the grounds during the tests.
- Qualifying entries will be announced at completion of the test.
- Bitches in season are permitted on the grounds & run at the end of the day.
- It is recommended that dogs competing have current immunization status.
- Safety requires that ALL walking in the field must wear an article of blaze orange clothing.

Lunch & Refreshments will be available at the grounds for a fee. Camping <u>MUST</u> be pre-approved by Liz at Pointblank (705 639-1236).

## AGREEMENT OF EACH ENTRANT

In consideration of the acceptance of my / our entry(ies) and of the holding of the

test and of the opportunity to have the dog tested and to win ribbons or trophies, I /we acknowledge and agree as follows:

- 1) The Ontario All Pointing Breed Field Dog Club (the O.A.P.B.F.D.C.) mayrefuse entry for any cause, which the O.A.P.B. F.D.C. deems to be sufficient.
- 2) Field tests have certain inherent dangers associated with them including, without limitation, those due to the presence and / or use of firearms, and as such any person participating in the test or being present on the test grounds assumes the associated risks.
- 3) To hold the Canadian Kennel Club (the C.K.C.), any C.K.C. approved judge, the O.A.P.B.F.D.C., Its members, directors, officers, agents, committee members, test secretary, official gunners at the test and the owners or lessor of the test grounds and any employees of any of them(collectively, the 'Club'), harmless from:
  - a) Any claim for loss or injury which may be caused or alleged to be caused directly or indirectly to any person or thing by any actof any dog I have entered in the test, or am responsible for, while in or upon the test; grounds or near any entrance to the test grounds.
  - b) Any claim for loss of any dog I have entered in the test, or am responsible for, by disappearance, theft, death or otherwise and from any claim for damage or injury to the dog, whether the loss, disappearance, theft, damage or Injury is caused or alleged to be caused by the negligence of the Club or any other person or any other cause or causes.
  - c) For bodily injuries, Including death at any time resulting from bodily injuries, sustained by any person or persons, including myself / ourselves, any minors for whom I / We is or are responsible or on account of damage to property arising out of or in consequence of my / our or their participation in the test orpresence on the test grounds, however such injuries, death or damage to property may be caused and whether or not caused or alleged to be caused by negligence of the Club or any of themor any other person; and;

I / we personally assume all responsibility and liability for any such claim; and I / we further agree to assume the sole responsibility for and agree to indemnify and save the Club harmless from any and all losses and expenses (including legal fees)by reason of the liability imposed by law or a court of competent jurisdiction upon the Club or any of them for any of the foregoing.
