

## EXHIBITOR INFORMATION

All dogs must be on a short leash and under control while on trial grounds except while trialing. **FLEXI LEASHES ARE NOT PERMITTED INSIDE ANY BUILDINGS.** Electronic collars/devices are not allowed anywhere on the site- this includes electronic bark collars as well as citronella collars. Head halters are also not allowed at BH trials. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited slip martingale and single piece slip collars/leads are allowed. Harnesses are allowed. Dogs **MUST** run "naked", without a collar/harness. Dogs should be brought into the ring with collars/harnesses which can be easily and quickly removed and replaced.

### RUNNING ORDER:

Dogs will be run in height order with dogs being handled by the same person separated into different staged groups.

Height Divisions: Small - dogs 13 inches and under, Medium - dogs 13 to 18 inches  
Large - dogs over 18 inches

### DAY OF ENTRY

Day of Entry entries will be accepted until one half hour before the trial begins.

\*Dogs are required to have a Barn Hunt Registration number to show in a Barn Hunt Trial. Register your dog online at: [www.barnhunt.com](http://www.barnhunt.com). Allow at least 48 hours to receive a Barn Hunt number. Handlers are responsible for entering and writing legibly the correct Barn Hunt number for their dog on entry form. An incorrect number may result in any legs earned being forfeited.

**Food & Drinks:** There will be a lunch break at the judge's discretion. Coffee, and water will be available. Lunch will be available for a fee.

**Volunteers:** All tasks are simple and we will train you!

**AWARDS:** Ribbons will be given for a qualifying run. Rosettes will be given for 1st through 4th place in each height category. Rosettes will be given for High in Class in each division. New Title rosettes will be given to dogs completing a title. Other prizes may be offered.

**Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial.** Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing. Please bring adequate water for you and your dogs.

### Refunds

Refunds minus a \$2 processing fee may be offered only for injured or sick dogs with veterinary note. Requests for refunds must be made by the closing date. Entry fees will **not** be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.

**Dogs must be ON LEASH at ALL times unless they are in the ring.**

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, may be asked to leave the site. In that case, no refund of any fees paid will be made.

**Dog exercise areas:** Please pick up after your dog and dispose of waste in appropriate containers outside the building. Please be considerate about picking up after your dogs and leaving the grounds as you found them. Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement per BHA regulations.

**Collars and Leashes:** Dogs may not be brought to the line in any disallowed collar. Dogs may not be brought to the start box on flexi-leads. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited slip martingale collars are allowed. Single piece slip collars/leads are allowed. Harnesses, with the exception of head-halter types, are allowed. Dogs MUST run "naked," without a collar/harness. Dogs should be brought to the ring with collars/harnesses which can be easily and quickly removed and replaced. All dogs must be on leash at all times except when in the ring.

**Refunds:** Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee. Exhibitors are responsible for complete, accurate and legible information on entry forms; illegible or incomplete entries cannot be entered in the trial. No refunds after the closing date unless a replacement entry is available from the wait list.

**Bitches in season** are eligible for entry but will be required to be kept separate from all other dogs and will be run in panties at the end of their class. Review the barn hunt rules for other details. *If bringing a bitch in season, please inform the trial committee prior to the trial, and you must inform all exhibitors at the judge's briefing.*

**Loud/Disruptive dogs;** Dogs that are loud and disruptive may be asked to locate away from the rings/crating area and/or staged away from the other dogs getting ready to compete. Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or trial committee. Any dog that is sick, injured or lame will be excused from the trial grounds.
