CANADIAN KENNEL CLUB INFORMATION

NON-MEMBER PARTICIPATION FEE POLICY

Effective January 1, 2011

- a) A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The fee will be \$59.40, plus applicable taxes.
- b) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- c) In order for the title to be awarded, the non-member will have a choice to either become a CKC

member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld.

- d) The fee applies only to dogs wholly owned by non-member residents of
- e) Canada and is not applicable to CKC members.

TEMPORARY COMPETITION NUMBER (TCN)

Effective November 1, 2019, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Temporary Competition number (TCN). This TCN does not register a dog for breeding purposes as defined in the Animal Pedigree Act, but rather enables a foreign-owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number. To obtain a TCN, go to the CKC website and register online. This number will automatically be generated once submitted and will be a 9 character registration number such as TC-AB1234567.

MIXED AND UNRECOGNIZED BREEDS

These events are open to mixed and unrecognized breeds. In order to compete, mixed and unrecognized breed dogs must have a Canine Companion Number (CCN) from the Canadian Kennel Club and must have a CKC-approved microchip. Mixed-breed dogs must be spayed or neutered. Unrecognized breed dogs do not need to be spayed or neutered. A dog eligible for a CCN may not be entered as a listed dog. If a dog is not registered individually in the CKC studbook it may be entered as a listed dog per CKC rules for this designation, as of July 1, 2018; exhibitors must apply to the CKC for "temporary competition number (TCN), before event closing date".

TITLES SHALL BE AWARDED ON THE BASIS OF THE FOLLOWING:

Three titles will be awarded for dogs that pass the Chase Ability Program event the required number of times. For purebred dogs, these are suffix titles that will appear on a dog's pedigree with a higher level title superseding a lower level title.

- 1. Chase Ability (CA) Awarded to a dog that passes the Chase Ability event three times under at least two different judges.
- 2. Chase Ability Excellent (CAX) Dog pass the CA event a total of
- 3. 10 times (CA + 7 additional passes)
- 4. Chase Ability Excellent 2 (CAX2) Dog passes the CA event a total of 20 times. A higher number title will be awarded for every ten (10) passes.

AWARDS:

Pass Certificates will be awarded to eligible dogs.


COURSE, ELIGIBILITY & CONDITIONS

COURSE

The club reserves the right to alter the course plan as required by weather and/or field conditions on the day of event. Course will be reversed for the second event.

ELIGIBLE BREEDS: Chase Ability Program participation is open to all purebred and mixed breed dogs at least 12 months of age that are individually registered with the CKC; or have an Temporary Competition Number (TCN); or have a Performance Event Number (PEN); or eligible for registration with the CKC; or have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed; or have a Canine Companion Number (CCN) if it's a mixed breed.

Dogs with breed disqualifications are eligible to enter. Females in season may not enter. A dog may enter only once per event. Dogs run as singles.



300-YARD COURSE: This distance is for dogs shorter than 12 inches at the withers or brachycephalic ("flat-faced") dogs. **Dogs will run one loop (right loop).**

600-YARD COURSE: This distance is used for all dogs that do not run the 300 yard course. **Dogs will run both loops (may be shortened)**.

If there is a question as to which course a dog will run the judge will decide.

CONDITIONS: All dogs will run individually. Slip leads recommended when starting your dogs. Muzzles may be used at owner's discretion. Dogs not present at roll call shall be scratched with no refunds. NO EXCEPTIONS. Lame dogs or bitches in season during roll call will be excused and their entry fees refunded.

RUNNING ORDER TO BE POSTED AFTER TEST DOG AT EACH EVENT

ATTENTION ALL EXHIBITORS:

OVERNIGHT PARKING & CAMPING IS PERMITTED RV Parking will be available at the trial site for \$10.00/night (Porta Potty on site – NO HOOK-UPS – No Open Fires)

FIELD CONDITIONS:

- All fenced, well away from roads
- Grass will be farm length (cut or grazed down, not mown to golf course length)
- No shade on field or camping area
- Very flat

ADDITIONAL INFORMATION:

- Port-a-potty on site
- NO POOP BAGs to be put in port-a-potty
- NO food or vendors on site, bring your own food/water for dogs
- There will be a \$10.00 fine for any loose dog interfering with a course in progress.
- Flexi Leads and Electronic Collars are not permitted on the field
- Dogs are expected to be aroused and excited in the presence of the lure, but handlers must be able to control their dogs for everyone's safety or they shall not be allowed to run. Additionally, the field committee reserves the right to bar known aggressive dogs from the event site
- The Host Clubs appreciates everyone's co-operation in keeping our site clean.
