Dead Ducks, Pheasants will be used at this trial. Males and females will be run in order of the draw. A system of rotation maybe used for the start of subsequent series in the All-Age Stakes. Wingers may be used in all stakes. Female dogs will not be vetted and handlers are reminded that bitches in estrus cannot compete in a CKC Licensed Trial. Eliminated dogs will be allowed to run out of contention in the minor stakes as time allows.
