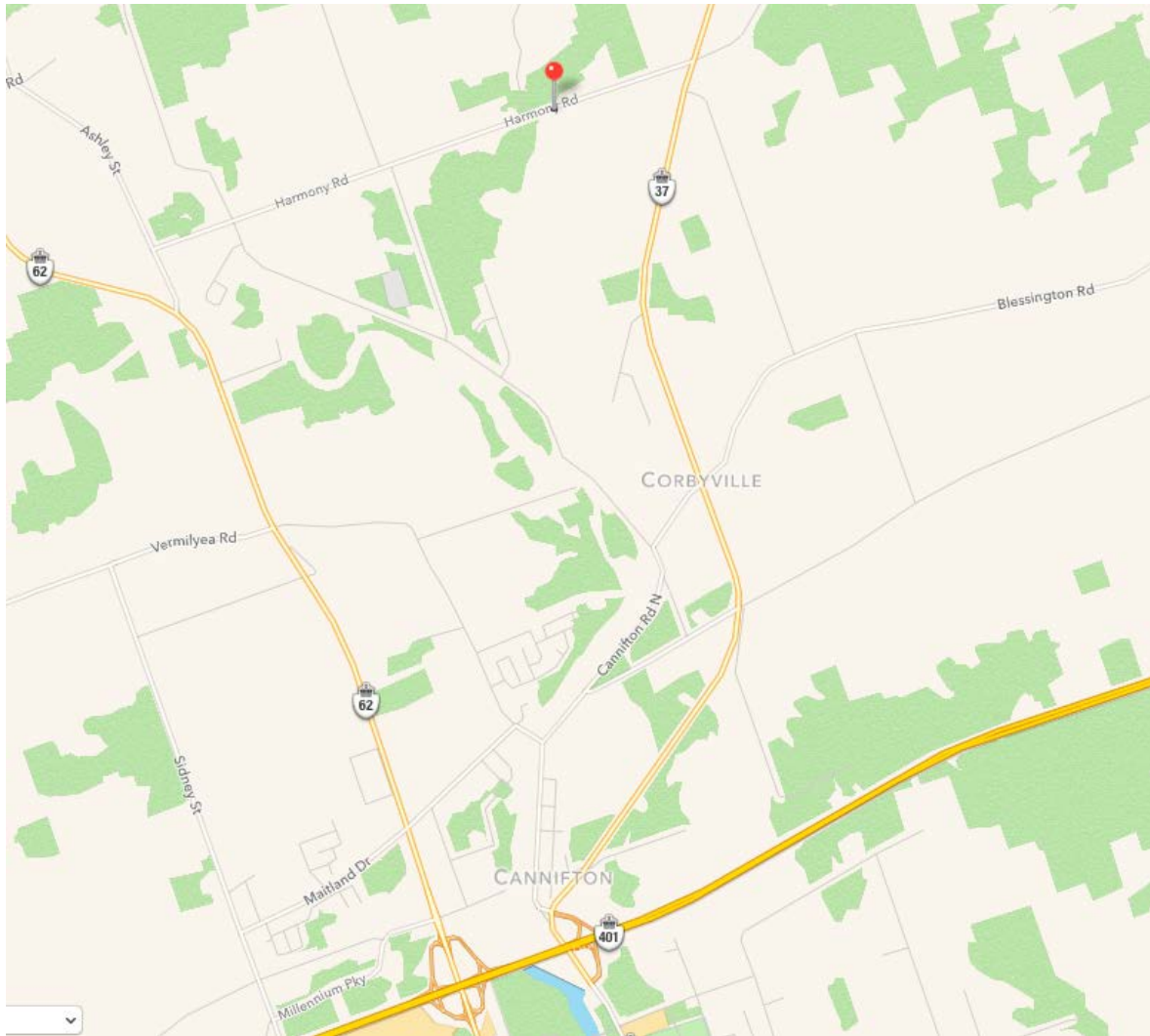

All particulars called for on the entry form must be complete. Any telephone calls required to confirm information will be made COLLECT. Exhibitors must abide by errors made in entering their dog/s regardless of how or by whom the entries were made. No entry will be accepted unless accompanied by full entry fees. The B&DKC cannot accept fax or phone entries and reserves the right to refuse any entry, subject to CKC rules. If because of riots, civil disturbances or acts beyond the control of the Trial Committee, it is impossible to open or complete the trial, no refund of entry fees will be made. All entry confirmation and judging schedules will be e-mailed as soon as possible after entries close.

Attention U.S. Exhibitors: We will accept U.S. cheques (checks) as noted in entry fees. Due to the constantly fluctuating currency rates, discounted checks will not be accepted. Personal checks will be accepted; however, they must be made payable in U.S. funds in amounts noted under entry fees. Listing Fees: A CKC listing fee of \$11.30 including HST Can. or US per dog per trial is payable with the entry fee if the entry of the dog does not include a CKC individual Registration number, PEN (Performance Event Number), ERN (Event Registration Number), or Miscellaneous Certificate Number (MCN).

Eligibility: To be eligible to compete in this trial, a dog must be at least 18 months of age and registered with the CKC or eligible for registration with the CKC, have a PEN, an ERN or have a CKC MCN (Miscellaneous Certificate Number). In addition, Mixed Breed with a CCN (Canine Companion Number) may compete. Bitches in season are not permitted to compete in the trial however, entry and listing fees will be returned, providing a veterinarian's certificate stating that the bitch was in season within the 10-day period preceding the trial is submitted to the Trial Secretary on or before the day of the trial. "It shall be the duty and obligation of the trial giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred". (4.1.3 t)

Awards and Prizes: (for qualifying scores, only)

Ribbons: Flat ribbons will be offered for all first to fourth place in each jump height in each class as well as for all qualifying scores.

Rosettes will also be offered for any new title earned at this trial.

Precincts of the trial: All grounds within 100' of the ring area or the fenced area of the grounds, whichever is less, shall be considered the trial grounds.

Course Familiarization: Handlers in all classes are permitted to walk the course, without a dog, prior to the start of each class. There will be a 5 minute break between the end of the walk-through and the first dog on the line. Warm-up jump/s will be provided in proximity to the ring area.

Move-up option: Dogs may be moved up to the next class between trials on the same day, by filling in the required move-up form.

Exhibitor Information: Exhibitors, through submission of entry, acknowledge that they are knowledgeable of and will comply with the **CKC Agility Rules and Regulations Effective January 2017**, a copy of which may be obtained by calling the Central Order Desk of CKC at 1-800-250-8040

Check-in will start Friday at 3:30 pm followed by PAD and Jumps and Tunnels 1 &2, Steeplechase. Trial 1 first dog will be on the line at 4:00 pm.

Saturday and Sunday check in begins at 7:15 a.m., with the first dog on the line at 8:00 am.

Equipment familiarization: There will be supervised contact equipment familiarization for Novice Dogs only, each morning before the Novice Std class.

Food: No food during the day is available on the grounds, but available within 5 min. of the trial grounds.

Running order: Small to Tall Fri and Sun. Tall to Small on Sat

- Novice class is open to dogs that have not acquired an Intermediate leg in the class entered.
- Intermediate class is open to dogs that have acquired the Agility Novice title, and to those dogs which have not yet acquired a qualifying score towards the Agility Excellent title in the class entered.
- Excellent class is for dogs that have acquired the Agility Intermediate title, but have not yet earned a qualifying score towards an Excellent title in the class entered.
- Master Excellent class is for dogs that have acquired the Agility Excellent title in the class entered.

Height Divisions

Handlers are responsible for entering the correct height division. The judge may request any dog be measured. **Selected** Class dogs will jump one height lower than the equivalent regular class height shown in the table below and dogs who measure 10" or below will jump 4" in the Selected Class. **Veteran** dogs may jump one or two heights lower. The following jump height divisions shall be use in all regular classes.

Obstacles:

Agility obstacles meet the requirements of the CKC Agility Rules

Note: A-Frame, Dogwalk, Teeter and Table have rubber surfaces and the tire is a breakaway self healing type. There will be no required position on the table and the count will be continuous. Six weave poles are in all Novice Classes. One bar jumps may be used at any level. A Frame is set at 5' for dogs jumping 12" or less and for the Steeplechase class and 5'6" for other runs. The is set 4" less than the regular jump height.

Electronic timing will be used at these trials. There will be **two rings** running alternately.

Camping

Overnight dry camping allowed at the trial site. No services but water will be available for fill-up.

Cost: \$10.00/day. Generators Allowed. Indoor flush toilets available.

List of the Major Changes to CKC Agility for 2017

New Titling Classes:

1. Jumps & Tunnels

This is an entry level class, open to all levels. It has no weave poles or contact obstacles. It is a time-plus-faults event and refusals or wrong courses are not faulted. This is expected to showcase the skill of handling at speed on wide open courses with no discrimination challenges.

2. International Challenge Class

This official class offers world class challenges in Standard and Jumpers with Weaves in the style of FCI type courses. These two classes are open to all levels and provide the opportunity to try out some European handling on courses that are slightly more challenging than the Master Excellent classes.

Category Changes:

The owner may choose to enter the Selected Category in lieu of entering the Regular Category at any trial. The dog must be entered only in Selected Category or in Regular Classes and may not move back and forth between the Selected Classes and the Regular Classes in the same trial, or associated group of trials. Once a dog is entered in the Selected Classes, the dog *may* go back to compete in the Regular Classes in a different trial.

Dogs moving into the Selected class *move laterally*, and **may choose to** take any legs they have earned in the Regular classes with them. If a Handler/owner does not want legs previously earned in Regular to be transferred to Selected when entering the Selected category, CKC *MUST* be notified to that effect, or the legs will be transferred automatically and certificates awarded on completion of the required legs.

New Division:

For the International Challenge Classes **ONLY**, there is an International Division. Handlers may optionally choose to enter their dogs in this division instead of the Regular division at a trial. The International division follows the three FCI jump heights, Small (12), Medium (16) and Large (24) and has different shoulder-height cutoffs.

Obstacle and Judging Changes:

SCT:

Yards per second used to calculate the Standard Course Times (SCT) have been changed for some heights and classes. Veterans now have 20% extra time added in all classes. Selected have 10% in all classes except Steeplechase, where they are allotted 20% extra time.

Weave Poles:

Missed poles must be corrected by restarting the weave poles over from the beginning.

A dog may make three attempts at the weave poles but must carry on to the next obstacle without completing the weave poles if the dog was not successful in three attempts. The judge will instruct the handler to move to the next obstacle and the dog will be faulted with a Failure to Perform "F". An attempt is defined as dog entering the poles and doing at least 2 poles. The three attempts are applicable to all levels including Novice. Although refusals are not faulted at the Novice level, the dog is still only allowed 3 attempts to successfully complete the weaves.

Tire:

Breaking open of the tire will incur the same as a knocked bar. "F" in Standard and JWW classes and 5 faults in Steeplechase and J&T

The tire must displace in response to 16-20 pounds of horizontal force with 18 pounds preferred. The setting will be confirmed by using a calibrated scale (in foot pounds) attached to a tire side mounting point. With one side secured to the frame, the opposite side is pulled using the scale until the segments pull apart. The breaking strength must be checked by the judge at the beginning of the trial.

Tunnels:

Maximum number of times that an open tunnel is to be performed is limited to three (3) in Standard classes. (Previously just JWW and Steeplechase)

Closed Tunnel has been suspended from use in all classes.

Numerous changes had been approved for this piece of equipment prior to its suspension. These changes have been left in the Rulebook until such time as the decision is made to remove the obstacle entirely or to re-instate its use.

Panel Jump:

A regular bar jump may be substituted for the panel jump in high winds.

Course Walkthrough times:

Judging must not begin sooner than 5 minutes after the end of the walkthrough. This is so that handlers with the first dogs on the line have an equal opportunity to walk the course and then prepare their dog for the ring.

Start and Finish Lines:

For both manual timing AND electronic timing, the start line shall be designated as the front plane of the first obstacle and the finish line defined as the front plane of the last jump, or back plane of the tunnel (if it is the last obstacle). Since the start line is the first obstacle, handlers may set their dogs when starting, at any distance from the approach side of the first jump, but the dog must remain inside the ring.

Contact Equipment:

Dogwalk

The up-contact will not be faulted.

Information on how to use in the fillable entry form:

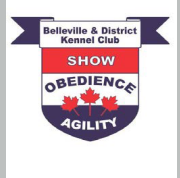
Bring up the entry form on your computer. Click on each area to be filled in and use the computer to input the information.
