Just a few rules to remember to keep things rolling along, to ensure that the facility will invite us back again and to welcome everyone to return to our trials and shows.

- **Be sure to be on time for your walk through/event and have your dog ready when your number is called.**
- **Dogs must be crated at all times, except when performing their event or in the ready ring. We want to keep the building entrance and aisle way clear for accessibility to the ring and exit.**
- **The warmup ring will be marked out and the next dog in the ring will be given priority for warming up.**
- **Remember to pick up after your dog. The building entrance and the Nadin lot are not potty areas. Go to the north end of the building to potty and please, please pick up. Garbage cans are located outside for your use.**
- **Owners are responsible for crate outbursts/continuous distracting noise by their dogs and will be asked to monitor their dogs closely or move them to wait in a vehicle.**
