As per the Working Certificate Test Rules and Regulations for Retrievers, Irish Water Spaniels and Poodles:

It shall be the duty and obligations of the test-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities or any kind. The Working Certificate Test Committee Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

CKC Non-Member Participation Fee Policy (Effective January 1, 2011)

- An annual fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.*
- In order to protect the awards/titles earned, the non-member will have the option to become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in all awards and titles being cancelled.*
- The fees apply only to dogs wholly owned by non-members and is not applicable to CKC members.*

Game: Ducks will be used for all land and water phases of the tests

Awards: CKC rosettes will be given to all dogs successfully completing test requirements.

Camping is available at test headquarters, 1374 Prospect Road, Woodville, Ontario, but no hookups are available.

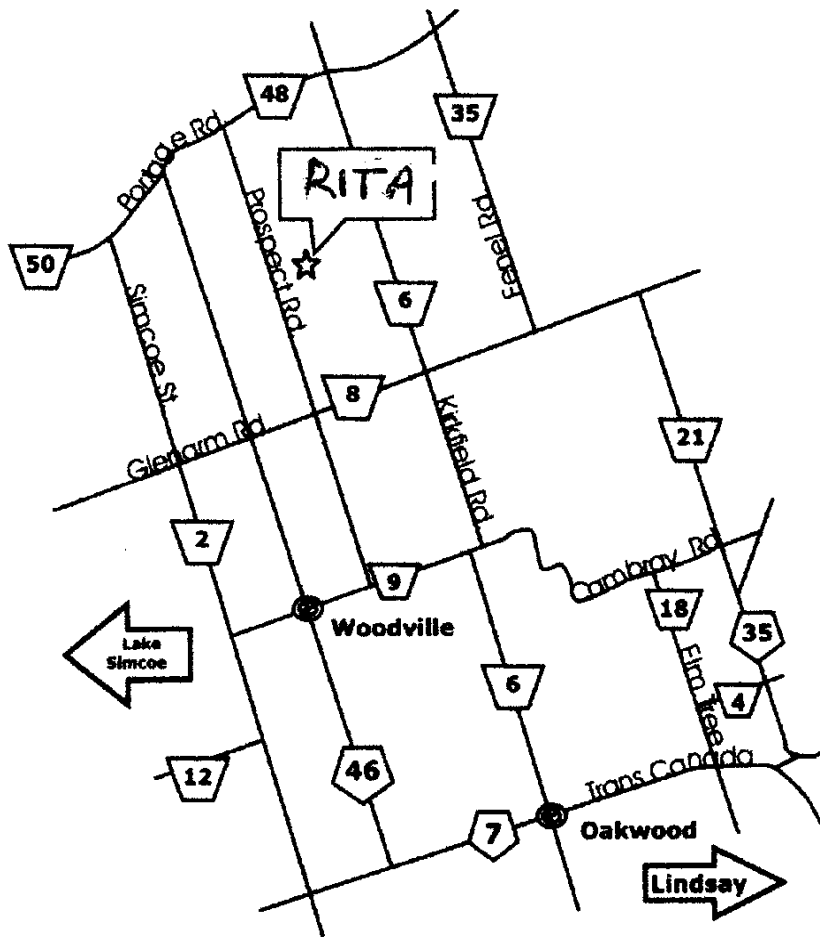

Directions



The show grounds are located at 1374 Prospect Road, north-east of Woodville, Ontario. Look for signs on routes as you get close to the site.

From the East, follow Highway 7 west of Lindsay approximately 10 km to the hamlet of Oakwood. Turn north (right) at the traffic lights in Oakwood and follow the Oakwood Road to a "T" junction. At the "T" junction, turn left onto Woodville Road 9. Drive approximately 2.4 km (1.5 miles) and turn north (right) onto Prospect Road. Follow the road north to show grounds (1374 Prospect Road), located on the east (right) side of the road.

From the West, follow Highway 7 east to the Hamlet of Oakwood. Turn north (left) at the traffic lights in Oakwood and follow the Oakwood Road to a "T" junction. At the "T" junction, turn left onto Woodville Road 9. Drive approximately 2.4 km (1.5 miles) and turn north (right) onto Prospect Road. Follow the road north to Test Headquarters (1374 Prospect Road), located on the east (right) side of the road.

From the North, follow Highway 12 south and turn east (left) onto Highway 48 East. Drive through Bolover. Turn south (right) onto the third road on the right (Prospect Road). Drive approximately 2.4 km (1.5 miles) to Test Headquarters (1374 Prospect Road), located on the east (left) side of the road.
